



A Special Road tax having been levied at the regular time of making the general county levy, as is provided in section 2562 of the Compiled Statutes of Wyoming for, 1910, Road Supervisor John Milliken presented the name of W. L. Jones as deputy or ex-officio Collector of such tax at snake river and vicinity, in Carbon County Wyoming.

It was regularly moved and seconded that W. L. Jones be and is appointed as such deputy or ex-officio collector of the Special Road Tax, for the year of 1911.

A petition signed by the residents of Snake River ~~asking/that/the/~~ Poor/Pauper/Faifor sanctioning the idea of the Board of County Commissioners in the purchasing a site and establishing a Poor and Pauper farm was received and ordered filed.

Pursuant to call for bids for the construction of a Road Way thru what is termed the Temple and Weber Lanes, there was filed byt one bid Geo. F. Sideon being the only bidder.

After due consideration it was regularly moved by Commissioner Veitch and Seconded by Commissioner McKay that the above mentioned bid, which is in amount of \$3,935.25, be rejected.
