

SPECIAL SESSION

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, April. 18th A. D. 1911.

Board met this 18th day of April 1911, in Special Session, pursuant to call issued by Chairman Evan Veitch, for the purpose of taking up the matter of making necessary improvements, upon the Roads near Baggs, and Elk Mountain. and to transact any other business, which may be of urgent nature, which may come before the board.

Roll call showing present Commissioners D. C. Jones, W. A. McKay, Evan Veitch Chairman, and Dee J. Wren Clerk.

Proceedings were had as follows to-wit:-

County Surveyor, J. R. E. Turpin, presented the survey of the road ect, near Baggs together with the approximate cost of building a tressel work and also of a dirt fill which is deemed necessary on said road, same having been washed out.

It having been made appear that the title to the lands, thru which the above mentioned road runs, is not clear in the name of the County, it was duly moved and seconded that before any extended work is preformed, that a good and sufficient deed be obtained conveying the warrented title to Carbon County.

Motion was duly put and carried.

The County Attorney was thereupon instructed to prepare such deed, the discription of which, be taken from the plat and survey, amde by the Co. Surveyor, and that the same be taken up with the owners of said lands covered by the desired right of way for the County Road, and to have the same signed and properly recorded at the earliest possible moment.

Petetion signed by the residents of Baggs and Vicinity, asking that the proposed fill be made with dirt and protesting against the construction of a tresselwork, was recieved and ordered filed.

Board adjourned to 2 o'clock P. M.

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, APRIL 19th A. D. 1911.

Board met pursuant to adjournment of April 18th. Roll call showing present Commissioners W. A. McKay, D. C. Jones, Evan Veitch, chairman and Dee J. Wren Clerk.

Proceedings were had as follows to-wit:-

Now comes F. R. Schoen and makes application for rebatement of taxes in amount of \$82.12, account of Erroneous assessment on Lands. After due consideration said rebatement was granted.

In the matter of improvements on road near Elk Mountain, it was made appear that a strip of road way, about one mile in length, was in need of immediate improvement.

After due consideration, it was decided that the three members of the board go to Elk Mountain, and view said piece of road, and to obtain a contract to have such work done.

Word was recieved from Mrs. Maggie Humphries, that she was unable to care for the three children, whom are orphans, and now in her charge, and set forth the fact that, correspondence had been recieved by her that, if these children were sent to Denver, Colo. that parties in Cripple Creek interested in the welfare of said children, would see that they were and are placed in a proper institution.

Thereupon it was regularly moved and seconded, that said children, be sent to Rawlins, and that one of the Board select some one to take the children to Denver, and see that they are properly placed.

Motion was duly put and carried.
