Whereas there is to be held a Carbon County Fair at Saratoga, Wyoming during the month of September, 1911, and

WHEREAS, Section 1331 of the compiled Statutes of Wyo. for 1910 authorizing the several Boards of County Commissioners to set aside a sum not to exceed \$500.00 for the purpose of Holding a County Fair when a petition signed by 50 qualified electors of the county,

AND WHEREAS the Carbon County Fair Association a duly incorporated body, having filed a petition signed by 50 qualified electors of Carbon county, and have fully complied with the said section 1331 of the Compiled Statutes of Wyoming for 1910.

NOW THEREFORE be it resolved that the sum of \$500.00 be set apart to be paid to the Carbon County Fair Association.

WHEREAS, Section 1336 of the Compiled Statutes of Wyoming for 1910, authorize the Board of the County Commissioners of the several Counties to appropriate money not exceeding Three Thousand (\$3,000.00) Dollars in any one year from the General Fund of the County for the purpose of developing the resources of the County and furthering its industrial development and for encouraging exhibits at fairs, ect; and

WHEREAS, It is deemed for the best interest of the County that at said County Fair, to be held in the Town of Saratoga in the month of September, 1910, the agricultural, mineral, live stock and other resources of the county should be exhibited, and that such exhibits should be encouraged;

THEREFORE be it resolved; that there is hereby appropriated out of the any funds in the General Fund of Carbon County, not otherwise appropriated, the sum of Three Hundred Fifty, (\$350.00) Dollars for premiums to be given for exhibits of live stock at such Carbon County Fair, in such classes as the managers of such Fair may deem most advisable, That there is also appropriated the sum of Three Hundred (\$300.00) Dollars, as premiums for exhibits of minerals from Carbon County to be exhibited at such Carbon County Fair and to be given for such classes and kinds of mineral as the managers of such fair may deem most advisable, That there is also appropriated a further sum of Three Hundred Fifty (\$350.00) Dollars for premiums for agricultural resources to be exhibited at such Carbon County Fair, for such classes as may be by the managers of such Fair deemed most advisable.

That the sum of Three Hundred Fifty (\$350.00) Dollars be appropriated for premiums up on exhibits of Domestic Articles made or produced by any woman resident of Carbon County, Wyoming to be exhibited at such Fair in such classes as may be deemed by the managers of such Fair most advisable.

Resolved that the several amounts herein appropriated be drawn from the Treasury by warrants duly signed and authenticated as provided by law, and drawn to the Treasurer of such Association for the purposes solely enumerated in this resolution, to be by him distributed to the persons awarded the premiums


in the various classes at such Fair.

And be it further resolved that the payment of the monies mentioned in the foregoing resolution be made as follows:-


