Dr. Nichols representing the Rawlins Gernerall Hospital and Medical Institute, appeared before the Board, and set forth that in a short time, not later than the first of the coming month, he would be able to take charge of all the County ~~patsitnes~~ patients.

It was moved by Commissioner Jones, and Seconded by Commissioner McKay that upon being notified the County Clerk, together with Dr. Nichols, should go to the Hospital at Rock Sptings, and take all the County Charges at such hospital and place same in the Rawlins General Hospital and Medicial Institute, at Rawlins, Wyoming. And further that all county pattients in the future after such above notificatio n has been filed. shall be placed in the above mentioned hospital at Rawlins. Motion put and carried.
