PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS SEPT. 3RD, A.D. 1912.

Board met pursuant to adjournment of Sept. 2nd. Roll call showing present Commissioners D. C. Jones, Wm. A. McKay Chairman and Dee J. Wren Clerk.

Meeting called to order by Chairman McKay.

Mr. Holcome representing the Union Pacific Railroad Company, and State Tax Commissioner McGill being present, the matter of taxation of Mineral Reservations of the Union Pacific Railroad Company was taken up.

Whereupon the following resolution was offered:-

WHEREAS, C. B. Boyce, County Assesor, did, for the year 1911, assess the Mineral Reservations underlying the deeded and contracted lands of the Union Pacific Railroad Company at 60 cents per acre and,

WHEREAS, the taxes for said year 1911 assessed against said Mineral Reservations were not paid but became delinquent and went to tax sale at which tax sale only a few pieces were sold by the County Treasurer, the authorized officer to conduct such sale and, ~~and~~

WHEREAS, on or about August 13th, 1912, at a conference held in Cheyenne, Wyoming between C. B. Boyce, County Assesor, and John McGill, State Tax Commissioner the said John McGill, did at that time, instruct said C. B. Boyce to assess the Mineral Reservations of the Union Pacific Railroad in Carbon County for the year 1912 as follows:-

All those Mineral Reservations underlying land purported by the United States Geological Survey to be coal formation at 50 cents per acre, and all lands lying outside of said purported coal formation at 25 cents per acre, and did, then and there, advise and suggest that the compromise be effected upon the unpaid 1911 tax upon the same values, less accrued penalty and interest.

THEREFORE, be it resolved that if the Union Pacific Railroad Company will redeem from the tax sale of June 1912, for delinquent taxes of 1911, such land as sold by the County Treasurer, then and in that event, said County Treasurer and Said C. B. Boyce County Assesor, are herein authorized and instructed to cancel upon the books of the County Treasurer all taxes now charged against said Mineral Reservations, and to enter upon the tax roll of 1911, under the head of "Additional or supplemental taxes", such land as was assessed in 1911 and unsold at said June tax sale, applying thereto the relative values of said 50 cents per acre and 25 cents per acre as is applied to the 1912 assessment, and extend against said values the 1911 state, county and school levies, and be it further resolved that after said taxes are spread upon the tax roll of 1911, the said County Treasurer is herein authorized and instructed.

to accept said taxes, plus advertiseing fees, and issue a receipt in full for all the taxes of 1911.

At the meeting of the State Board of Equalization the rate of levy upon each Dollar of Valuation for State Revenue for the year of 1912, was fixed at 3 and 8 hundredths mills and the Board were thereby directed to make this levy as provided by law.

It is hereby ordered by the Board of County Commissioners that the following amounts be levied and assessed upon each and every Dollar of the taxable, real and personal property in said County and State of Wyoming and upon the assessed valuation thereof as is shown by the assessment roll of said Carbon County, State of Wyoming for the year of 1912, including the valuation of property of Railroad, car and telegraph Companies as assessed to them by the State Board of Equalization.

The contract for the above mentioned construction of bridge is hereby awarded to The Colorado Bridge and Construction Company.

The bids as were opened at 12 o'clock noon of this day for the construction of Cement walks and walls at Court house, as per call for bids made, and according to the specifications and plans were ordered read.

The Bid of H. Larson, in amount of \$1075.00 being the only bid, it was moved by Commissioner McKay that in as much as the the amount bid was in very close figures with the estimate made by the County Surveyor, that the contract be awarded to H. Larson for the improvements mentioned above, at the Court House.

Therewupon Chairman McKay declared the contract be and is herdy awarded to H. Larson.
