SPACE AROUND THE POLLS.

Section 2200 of Chapter 150 of the Pamphlet Entitled Election Laws of Wyoming, 1911. provides for the space around the Polls as follows:-

"A space of Twenty feet in every direction from the ~~polls~~ shall be kept open and clear of all persons, except one challenger of good conduct and behavior, selected by each political party to detect and challenge illegal voters; Provided, that where the polling place is in an established building, or it would entail unnecessary expense upon the county to build such polling booth, the space of twenty feet need only be in such direct on from the building and in such way ~~as affixed~~ ~~as affixed~~ ~~as affixed~~ ~~as affixed~~ ~~as affixed~~ as would leave clear space for the easy entrance and exit of all electors, to and from the polling place, without hindrance or molestation of any one.
