Board met pursuant to adjournment of morning session. Roll call showing all members present. Proceedings were had as follows, to-wit;-

Sale of Property.

BE IT RESOLVED, That WHEREAS, lots 19 and 20, block 123 in the Town of Encampment Wyoming, were sold for the 1908, taxes on July 15th 1909, and WHEREAS, said property was bid in by Carbon County, at such sale and WHEREAS, the time for redemption of said land has expired, whereby title to said lands passed into Carbon County, and WHEREAS, W. W. Pankey has offered to pay to Carbon County to the amount of said Lots No. 19 and 20 Block 123 was sold for together with all interests, costs, taxes assessed against said lands due and remaining unpaid to date and other expenses incurred to date amounting to a total of \$2.42. NOW THEREFORE, be it resolved by the Board of County Commissioners, that the said lands be sold to W. W. Pankey for the said sum of \$2.42 and the Chairman of this Board and the County Clerk are hereby authorized and instructed to prepare and execute a proper deed of conveyance to the said property to the said W. W. Pankey.

ROAD LOCATION OF.

A petition for the establishing of a County Road, which was filed at the last April meeting, was ordered taken up. Said road being described as follows:- Commencing at a point being the Section corner on the West between Sections 1 and 12 Township 13 Range 92 West and running East to the quarter corner between the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 6 and the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of section 7 Township 12 North Range 91 West of the 6th P. M. it being understood that the right of way is donated from the starting point to the Township line between Townships 13 and 12 it being especially petitioned for a road through the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section Seven Township 12, N. R. 91, West of the 6th P. M. on Section line north of said subdivision.

Whereupon it was ordered that Commissioners Wm. A. McKay and D. C. Jones, be and they are hereby ~~appointed~~ appointed as viewers of said road way and to report as is by law provided in such cases. at the next Special or Regular meeting.

There being no further business, but owing to the above road ~~way~~ establishment, it was ordered that the the Board adjourn subject to a call of the Chairman for a Special Meeting. Board so adjourned.
