Letter from the State Board of Charities and Reform stating that Dr. Thomas C. Letter from the Assistant Commissioner of Mines and Minerals, asking for samples for display at the Wyoming State Fair, was received. Whereupon it was ordered by the Board that any one having samples taken from property within the County, if delivered at the County Seat, (Rawlins) that they, the Board would ship same free from charge to Douglas, and there same will be exhibited during the State Fair, after which they will be turned over to the Wyoming State University for use in their Mineralogical Displays.

Sale of Property.

BE IT RESOLVED, That WHEREAS, lots 6 and 7 Block 32, in the Town of Encampment Wyoming, was sold for taxes July 15th 1909 for the 1908 Taxes, and WHEREAS, said property was bid in by Carbon County, at such sale, and

WHEREAS the time for redemption of said land has expired, whereby title to said lands passed into Carbon County, and

WHEREAS W. L. Mathews has offered to pay to Carbon County to the amount of said lots No. 6 and 7 Block 32 was sold for together with all interests, costs, taxes assessed against said lands due and remaining unpaid to date and other expenses incurred to date amounting to a total of \$14.55.

NOW THEREFORE, be it resolved by the Board of County Commissioners, that the said lands be sold to W. L. Mathews for the said sum of \$14.55 and the Chairman of this Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said property to the said W. L. Mathews.
