

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, JULY 6TH A. D. 1912.

Board met this 6th day of July A. D. 1912, pursuant to adjournment of July 2nd, Roll call showing present Commissioners, D. C. Jones, Evan Veitch, Wm. A. McKay Chairman and D. G. Wren, Deputy County Clerk.

Meeting called to order by Chairman McKay.  
Election Districts.

In Compliance with Chapter 146 of the Compiled Statutes of Wyoming for 1910, The Board established elections Districts as follows, also Election Precincts in the Several Districts.

DISTRICT NO. 1 RAWLINS.

All that territory embraced within the following boundaries shall be known as Election District No. 1.

Commencing at the Township 20 on the line between ranges 85 and 86, Thence north along said Range lines 85 and 86, to the line between Townships 24 and 25 Thence along the line between Townships 24 and 25 to the boundary line between Carbon and Sweetwater Counties ~~thence along the~~ line between Carbon and Sweetwater Counties to the line between Townships 19 and 20, Thence east along said line between Townships 19 and 20 to the place of beginning.

DISTRICT NO. 2? FERRIS AND SEMINOE

Ferris and Seminoe District No. 2 shall consist of all that territory embraced within the following boundaries. Commencing at the South East Corner of Township 25 on the line between Ranges 84 and 85, Thence north along said line between Ranges 84 and 85 to the boundary line between Carbon and Natrona Counties, Thence west along said boundary line between Carbon and Natrona Counties to the North west corner of Carbon County. Thence south along the western boundary of Carbon County to the line between Townships 24 and 25, Thence east along said line between Townships 24 and 25 to the place of beginning.

DISTRICT NO. 3. FORT STEELE.

All that territory embraced within the following boundaries shall be known as Fort Steele ~~District~~ Election District No. 3.

Commencing at the South east Corner of Township 20 in the line between Ranges 84 and 85, Thence north on the said line between Ranges 84 and 85 to the line between Townships 24 and 25, Thence west along said line between townships 24 and 25 to the Line between Ranges 85 and 86, Thence south along said line between Ranges 85 and 86 to the line between Townships 19 and 20 Thence east along said line between Townships 19 and 20 to the place of beginning.

DISTRICT NO. 4 LEO.

All that territory embraced within the following boundaries shall be known as Leo Election District No. 4.

Commencing at the South East corner of Township 24 on the line between Ranges 80 and 81, thence north on said line between ranges 80 and 81 to the

bounday line between ~~Carbon~~ Carbon and Natrona Counties, Thence west on said ~~line~~ line between Carbon and Natrona Counties to the line between ranges 84 and 85 Thence south on said line between ranges 84 and 85 to the line between townships 24 and 25 Thence east on said line between townships 24 and 25 to the line between ranges 83 and 84, Thence south on said line between ranges 83 and 84 to the line between ~~townships~~ townships 23 and 24, thence east on said line between townships 23 and 24 to the place of beginning.

#### DISTRICT NO. 5 MEDICINE BOW.

All that territory embraced within the following boundaries shall be known as Medicine Bow Election District No. 5.

Commencing at a point on the boundary line between Carbon and Albany Counties and on the line between Townships 21 and 22, in Range 77, Thence north on said eastern boundary line of Carbon County to the North east corner of Carbon County Thence west along the northern boundary line of Carbon County to the line between ranges 80 and 81, thence south on said line between ranges 80 and 81 to the line between Townships 23 and 24, thence east on said line between townships 23 and 24 to the line between ranges 78 and 79, thence south on said line between ranges 78 and 79 to the line between Townships 21 and 22, thence east on said line between Townships 21 and 22 to the place of beginning.

#### DISTRICT NO. 6. HANNA.

All that territory embraced in Townships 22, 23 and 24 in Ranges 81, 82 and 83 shall be known as Hanna Election District No. 6.

#### DISTRICT NO. 7. CARBON.

All that territory embraced within the following boundaries shall be known as Carbon Election District No. 7.

Commencing at the south east corner of Township 22 on the line between Ranges 78 and 79, Thence north on said line between Ranges 78 and 79 to the line between Townships 23 and 24, thence west on said line between ~~ranges~~ Townships 23 and 24 to the line between Ranges 80 and 81, Thence south on said line between Ranges 80 and 81 to the line between Townships 21 and 22, Thence east on said line between Townships 21 and 22 to the place of beginning.

#### DISTRICT NO. 8. Elk Mountain.

All that territory embraced within the following boundaries shall be known as Elk Mountain Election District No. 8.

Commencing at the boundary line between Carbon and Albany Counties and on the line between Townships 19 and 20, thence north on the said eastern boundary line of Carbon County to the line between Townships 21 and 22, thence west on said line between Townships 21 and 22 to the line between Ranges 80 and 81, Thence south on said line between Ranges 80 and 81 to the line between Townships 19 and 20, thence east on said line between Townships 19 and 20 to the place of beginning.

#### DISTRICT NO. 9 ROCK DALE

All that territory embraced within the following boundaries shall be known as Rock Dale Election District No. 9.

Commencing on the boundary line between Carbon and Albany Counties and on the line between Townships 16 and 17, Thence north on said County line to the line between Townships 19 and 20, Thence west on said line between Townships 19 and 20 to the line between Ranges 80 and 81, thence south on said line between Ranges 80 and 81 to the line between Townships 18 and ~~19~~ 19, thence west on said township line between Townships 18 and 19 to the range line between Ranges 81 and 82, thence south on said line between Ranges 81 and 82 to the line between Townships 17 and 18, thence east on said township line to the line between ranges 79 and 80, thence south on said line to a point between townships 17 and 17, thence east on said line between townships 16 and 17 to the place of beginning.

## DISTRICT NO. 10 GREEN.

All that territory embraced within the following boundaries shall be known as Green Election District No. 10.

Commencing at the south east corner of Township 19, Range 81, Thence north of the line between Ranges 80 and 81, to the line between Townships 20 and 21, Thence west along the line between Townships 20 and 21 to the line between Ranges 83 and 84, thence south on said line between Ranges 83 and 84 to the line between Townships 18 and ~~19~~ 19, thence east on said line between Townships 18 and 19 to the line between Ranges 80 and 81 the place of beginning

## DISTRICT NO 11. SARATOGA.

All that territory embraced within the following boundaries shall be known as Saratoga Election District No. 11.

Commencing at the south east corner of Section 1, Township 16 Range 83, thence north on the line between ~~Townships 17 and 18~~ Ranges 82 and 83 to the line between Townships 17 and 18, thence east on said line between Townships ~~between~~ 17 and 18 to the line between ranges 81 and 82, thence north along said line between ranges 81 and 82 to the line between Townships 18 and 19, thence west along said line between townships 18 and 19 to the line between Ranges 85 and 86, thence south on said line between Ranges 85 and 86 to the line between Townships 17 and 18, thence west on said line between townships 17 and 18 to the line between Ranges 87 and 88, Thence south on said line between Ranges 87 and 88, to the line between ~~Townships~~ Townships 16 and 17 Thence east on said line between Townships 16 and 17 to the line between Ranges 83 and 84, thence south on said line ~~between~~ between Ranges 83 and 84 to the south west corner of Section 6, Township 16 north Ranges 83, thence due east to the south east corner of Section 1, Township 16 N. R. 83, the place of beginning.

## DISTRICT NO.12. ENCAMPMENT.

All that territory embraced within the following boundaries shall be known as Encampment Election District No. 12.

Commencing at the south east corner of Township 15 Range 83, Thence north  
to the south east corner of Section No. 4, Township 16, Range 83, ~~thence north~~  
~~to the south east corner of Section No. 4, Township 16, Range 83.~~

Thence west to the south west corner of Section No. 6, Township 16 Range 83, thence north to the northeast corner of Township 16, Range 84, Thence west to the line between Ranges 85 and 86, thence south on said line between Ranges 85 and 86 to the line between Townships 14 and 15, thence due east to the place of beginning.

ELECTION DISTRICT NO. 13 BENNETT.

All that territory embraced within the following boundaries shall be known as Bennett Election District No. 13.

Commencing on the boundary line between Carbon and Albany Counties and on the line between Townships 14 and 15, Thence north on said eastern boundary line of Carbon County, to the line between Townships 17 and 18 thence west on said line between Townships 17 and 18 to the line between Ranges 82 and 83, Thence south on said line between Ranges 82 and ~~83~~ 83 to the line between Townships 14 and 15 thence east on said line between Townships 14 and 15 to the place of beginning.

DIST ICT NO. 14, ~~BENNETT~~. *Collins*

All that territory embraced within the following boundaries shall be known as Collins Election District No. 14.

Commencing on the boundary line between Carbon and Albany Counties and on the Boundary line of the States of Wyoming and Colorado, Thence north on the eastern boundary line of Carbon County to the line between Townships 14 and 15 thence west on said line between Townships 14 and 15 to the line between ranges 86 and 87, thence south on said line between ranges 86 and 87 to the line between Sections 19 and 30 Township 14 Range 86, Thence east on said line between sections 19 and 30 to the corner of Sections 19, 20, 29 and 30, Thence south on said line between sections 29, and 30 and 31 and 32 to the township line between townships 13 and 14, Thence <sup>East</sup> on the said township line between townships 13 and 14 to the line between ranges 85 and 86 thence south on said range line between ranges 85 and 86 to the Colorado state line thence east along said Colorado State line to the place of beginning.

DISTRICT NO. 15. SNAKE RIVER.

All that territory embraced within the following boundaries shall be known as Snake River Election District No. 15.

Commencing at the point of intersection of the Colorado State line and the line between Ranges 85 and 86, thence north on said line between Ranges 85 and 86 to the line between townships 13 and 14, thence west on said line between townships 13 and 14 to the section line between sections 31 and 32, township 14 Range 86

Thence north on said section line between sections 31 and 32 and 30 and 29 to sections corner between sections 19, 20, 29 and 30, thence west on said section line between sections 19, and 30 to the line between Ranges 86 and 87, thence north on said range line between ranges 86 and 87 to the line between townships 14 and 15 Thence east on the line between townships 14 and 15 to the range line between ranges 85 and 86, Thence north on said range line between ranges 85 and 86 to the line between townships 16 and 17, thence west on said township line between





Township 25 Ranges ~~84~~<sup>85</sup> and ~~85~~<sup>86</sup>; The ~~E $\frac{1}{2}$~~  of Township ~~26~~<sup>25</sup> Range ~~86~~<sup>87</sup>, and the  $S\frac{1}{2}$  of Township 26 Range ~~84~~<sup>85</sup> and ~~85~~<sup>86</sup> and the  $SE\frac{1}{4}$  of Township 26 Range 87.

✓ Ferris Precinct No. 2 shall consist of all that territory embraced within the  $N\frac{1}{2}$  of Township 26 Ranges 85 and 86;  $NE\frac{1}{4}$  of Township 26 Range 87; Township 27 Ranges 85 and 86; and  $E\frac{1}{2}$  of Township 27 Ranges 87; and Township 28 Ranges 85 and 86. *Q. 28 R. 87.*

✓ Whiskey Gap Precinct No. 3 shall consist of all that territory embraced within The  $W\frac{1}{2}$  of Township 28 Range 87; All of Township 28 in Ranges 88 and 89 ~~W $\frac{1}{2}$~~   $W\frac{1}{2}$  Township 27 Range 87 all ~~W $\frac{1}{2}$~~  27 in Ranges 88 and 89 and the  $W\frac{1}{2}$  of Township 26 Range 87 All of Township 26 Ranges 88 and 89; The  $W\frac{1}{2}$  of Township 25 Range 87 and all of Township 25 Ranges 88 and 89.

#### DISTRICT NO. 3.

Election District No. 3 shall consist to one Election Precinct.

✓ Fort Steele Precinct No. 1, shall consist of all the following territory. All of Townships 20, 21, 22, 23, and 24 Range ~~84~~ 85.

#### ELECTION DISTRICT NO. 4.

Election District No. 4 shall consist of 3 election precincts.

✓ Leo Precinct No. 1 shall consist of all territory in said Election District embraced within ~~Townships~~ Townships 24 Ranges 81., 82 and 83 and Township 26 Ranges 83 and 84. *and Twp. Ranges 81, 82 & 83, 84*

✓ Shirley Precinct No. 2 shall consist of all territory in said Election District No. 4, in Townships 27 and 28 Ranges 81, 82, 83 and 84 and township 26 in Ranges 81 and 82.

✓ Cowdin Precinct No. 3 shall consist of all territory embraced within the following boundaries. Beginning at the Southeast corner of Township 26 Range 81 Thence north to the southeast corner of Township 27 Range 81 Thence west along the line between Townships 26 and 27 to the north west corner of Township 26 Range 82 thence south to the south west corner of township 26 thence east to the place of beginning.

#### ELECTION DISTRICT NO. 5.

Election District No. 5 shall consist of one Election Precinct.

✓ Medicine Bow Precinct No. 1, shall consist of all that territory embraced within said Election District No. 5.

#### ELECTION DISTRICT No. 6.

Election District No. 6 shall consist of Two Election Precincts.

✓ Hanna Precinct No. 1 shall consist of all that territory embraced within said Election District except Sections ~~16 and 17~~ 16 and 17 Township 22 Range 81.

✓ Hanna Precinct No. 2 shall consist of all that territory embraced within Sections 16 ~~and 17~~ 22 Township 22 Range 81.

#### ELECTION DISTRICT NO. 7.

Election District No. 7, shall consist of One Election Precinct.

✓ Carbon Precinct No. 1, shall consist of all that territory embraced within Election

## ELECTION DISTRICT NO. 8.

Election District No. 8 shall consist of One Election Precinct.

✓ Elk Mountain Precinct No. 1 in said election District Number One shall consist of all that territory embraced within said Election District.

## ELECTION DISTRICT NO. 9.

Election District No. 9 shall consist of three Election Precincts.

✓ Rockdale Precinct No. 1 shall consist of all that territory embraced within Township 19 Ranges 77, 78 and 79 in said Election District No. 9.

✓ Morgan Precinct No. 2 shall consist of all that territory embraced within Townships 17, and 18 Ranges 77, 78 and 79.

✓ Widdowfield precinct No. 3 shall consist of all that territory embraced with Townships 18 and 19 Range 80 and Township 18 in Range 81.

## ELECTION DISTRICT NO. 10.

Election District No. 10 shall consist of One Election Precinct.

✓ Green precinct No. 1 shall consist of all that territory embraced within said Election District No.

## ELECTION DISTRICT NO. 11.

Election District No. 11 shall consist of one Election Precinct.

✓ Saratoga precinct No. 1 shall consist of all that ~~portion~~ the territory embraced within said Election District No. 11.

## ELECTION DISTRICT NO. 12.

Election District No. 12 shall be divided into 3 Precincts.

✓ Cow Creek Precinct No. 2 shall consist of all that territory embraced in said election District No. 12 divided by Cow creek except that divided by Calf Creek.

✓ Spring Creek Precinct No. 3 shall consist of all that territory embraced in said election district No. 12 divided by spring creek and Calf Creek. *Except that part embraced within*  
*Riverside Precinct No. 4 shall consist of Townships 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71, 72, 73, 74, 75, 76, 77, 78, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100.*

Election District No. 14 shall consist of 3 Precincts.

✓ Collins Precinct No. 1, shall consist of all that territory embraced within Townships 12, 13 and 14 Ranges 82 and 83.

✓ Encampment Precinct No. 8 shall consist of all that territory embraced within that Part of Township 14 Range 86, embodied in Said Election District, and all of

Townships 12, 13 and 14 Range 85. Townships ~~12~~ 13 and 14 Range 84 Except that part embraced within the town of Riverside, and Precinct.

✓ Enc. Tie Camp, All of Township 12, Range 84 in said Election District No. 14.

✓ Big Creek No. 7 Precinct consists of all that portion of Election District No. 14 in Townships 12, 13 and 14 Ranges 80 and 81.

#### ELECTION DISTRICT NO. 15,

Election District No. 15 shall consist of 4 Precincts.

✓ Savery Precinct No. 2 shall consist of all that portion of Election District No. 15 embraced within Townships 12, 13, 14, 15, & 16 Ranges 86, 87, 88 and 89.

✓ Dixon Precinct No. 3 shall consist of all that portion of said Election District No. 15 embraced within Townships 12, 13, 14 and 15 Range 90.

✓ Baggs Precinct No. 4 shall consist of all that portion of said Election District No. 15 embraced within Townships 12, 13, 14 and 15 Ranges 91 and 92.

✓ Sand Creek Precinct No. 5 shall consist of all that portion of said Election District No. 15 embraced within townships, 12, 13, 14 and 15 Range 93.

#### ELECTION DISTRICT NO. 16,

Election District No. 16 shall consist of 3 Precincts.

✓ Sulphur Precinct No. 2 shall consist of all that portion of Election District No. 16 embraced within Townships 16, 17, 18 and 19 Ranges 89, 90 and 91.

✓ Pine Grove Precinct No. 1 shall consist of all that portion of Election District No. 16 embraced within Townships 16, 17, 18 and 19 Range 88.

✓ Adams Precinct No. 3 shall consist of all that portion of Election District No. 16 embraced within Townships 16, 17, 18 and 19 Ranges 92 and 93.

#### ELECTION DISTRICT NO. 17.

Election District No. 17 shall consist of 2 Precincts.

Rankin Precinct No. 1 shall consist of all that portion of Election District No. 17, embraced within said Election district except, Townships <sup>19</sup> 20, 21, 22, 23 and 24 Range 84.

Walsott Precinct No. 2 shall consist of all that portion of Election District No. 17 embraced within Townships <sup>19</sup> 20, 21, 22, 23 and 24 Range 84.

✓ Difficulty Precinct. Be it resolved there be and there is hereby created a Polling Precinct to be known as Difficulty Precinct No. 5 in Election District No. 4, to conform with the resolution passed at the meeting of the Board Oct. 5th 1910. said precinct to be taken from districts numbers 5 and 4 and embracing townships 24 and 25 Range 80. and Townships 24 and 25 Range 81.

✓ Pedro Precinct No. 4 in District No. 4 shall consist of all that territory embraced within townships 27 and 28 Ranges 83 and 84.
