Proceedings were had as follows, to-wit:-

BE IT RESOLVED. That whereas Lot 6 in Block 87 in the Town of Grand Encampment, Wyoming was sold June, 1911, for 1910 taxes, and

WHEREAS, There being no other bidders, said property was bid in by said Carbon County at such sale, and

WHEREAS, The time for redemption for said Lot has expired whereby the title to said lot passed into Carbon County, and

WHEREAS, C. H. Ashley has offered to pay to Carbon County to the amount of \$16.75 for said lot. The amount of said lot 6 in Block 87 was sold together with all costs, penalties, interest and expenses incurred to date amounting to a total of \$16.75.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said lots be sold to said C. H. Ashley for the sum of \$16.75 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said C. H. Ashley.

BE IT RESOLVED That whereas the Southwest Quarter of the Northeast Quarter of Section Four (4), Township, Seventeen (17), North Range Ninety (90) was sold to the County on July, 20th. 1910 at delinquent sale, and

WHEREAS, There being no other bidders said property was bid in by said Carbon County at such sale, and

WHEREAS, The time for redemption for said land has expired whereby the title to said land passed into Carbon County, and

WHEREAS, S. Park has offered to pay to Carbon County to the amount of \$8.06 for said land. The amount of said land was sold together with all costs, penalties, interest and expenses incurred to date amounting to a total of \$8.06.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said land, The Southwest Quarter of the Northeast Quarter of Section Four (4), in Twp. It was moved by Commissioner Mc Kay and Secnded by Commissioner Day that \$500. be appropriated out of the General Fund to each Road District for Road and Bridge purposes. Motion carried.
