



Board met pursuant to adjournment of March, 5th. 1913.

Roll Call showing present Commissioners Robt. A. Day, D. C. Jones, Wm. A. Mc Kay  
Chairman and L. B. Magor. Clerk.

Proceedings were had as follows:- to-wit:-

In accordance with Section 2287 of a pamphlet entitled Election Laws of the  
State of Wyoming, Town Clerk Emil Grooman filed a notice of Special Municipal  
Election to be held in the City of Medicine Bow, Wyoming on the 1st. day of April,  
A. D. 1913. to decide whether the town shall issue bonds for \$30000, with which to  
construct water works for the said town.

Reports of Justice of the Peace Jno. C. Friend. Rawlins Precincts 2 & 3, John  
Owens, Rawlins Precinct No. 1. Ewd. Mc Atee, Hanna, E. L. Blood, Saratoga, A. B.  
Sager. Ft. Steele, received, examined, approved and ordered filed.

Petition was presented asking that J. F. Clearwater be appointed Justice of the  
Peace of Rockdale Precinct whereupon it was moved by Commissioner Day and seconded  
by Commissioner Jones that J. F. Clearwater be appointed Justice of the Peace of  
Rockdale Precinct. Motion Carried.

The report of S. Park, County Treasurer was read and examined, showing \$14822.92  
available for General Expenses was approved and ordered filed.

The matter of having a County Physician at Hanna was discussed and it was  
moved by Jones and seconded by Day that H. J. Mc Arthur be appointed County  
Physician at Hanna, Wyoming.
