S. Park County Treasurer appeared before the Board and suggested that the assessment and the sale of the Verde Mining & Smelting Co. Property in the year 1910, be annulled on account of it being wrongly described by the assessor on our tax rolls.

Moved by Mc Kay and seconded by Jones that the above assessment be annulled and the Treasurer be instructed to properly assess this property for the past five years and in case of the Taxes not being paid, sell it at our delinquent sale to be held during the current year.

The SE $\frac{1}{4}$ of Section 17, Twp, 14. Range was erroneously described by the Assessor

in the years 1909, 1910, and 1911 as the SE $\frac{1}{4}$ of section 14, Twp. 14, Range 85.

Whereupon the Board instructed the County Treasurer to change the description the tax books to read as the SE $\frac{1}{4}$ of section 17, Township 14, Range 85 to correspond with the records on the books in the office of the County Recorder.
Assignment of Title.

At a Tax Sale of Delinquent taxes in June 1912 property belonging to the Portland Copper Mining Co. (being Mining Claims) ; there being no other bidders was bid in by the County for the amount of such delinquent taxes .

A bid was received from Joseph C. Helm of Denver, Colo. of \$43.95 petitioning the Board of County Commissioners of Carbon County for permission to pay the said amount and take an assignment from the county in proper form of its interests in the property under the tax sale above mentioned , this amount \$43.95 being sufficient to cover all costs, -principal and interest and also the 1912 taxes.

It was moved by Commissioner Mc Kay and seconded by Commissioner Day , same be accepted proper assignments made to Joseph C. Helm. Motion Carried.

Sale of Property.

BE IT RESOLVED, that WHEREAS, THE WASATCH MINING CLAIM Situated in Sections 23, and 24, Township 14, Range 86 was sold for taxes to the County at delinquent sale held in 1910 and

WHEREAS the time for redemption of said land has expired , whereby title to said lands passed into Carbon County, and

WHEREAS R. Z. Mc Coy, one of the actual owners has offered to pay Carbon County to the amount of said, (Wasatch Mining Claim.) situated in Sections 23 and 24, Twp. 14, Range 86 was sold for together with all interests, costs, taxes assessed against said lands due and remaining unpaid to date and other expenses incurred to date amounting to a total of \$8.50.

NOW THEREFORE, be it resolved by the Board of County Commissioners, that the said lands be sold to Mr. R. Z. Mc Coy for the said sum of \$8.50 and the Chairman of this Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said property to the said R. Z. Mc Coy.
