These properties were sold to the County for Taxes in 1911. House Bill No. 22.

An act to amend and re-enact Section 2547, of the Compiled Statutes of Wyoming of 1910, providing that Counties may be divided into Road Districts.

Be it enacted by the Legislature of the State of Wyoming.

COUNTIES SHALL BE DIVIDED.

Section 1, Section 2547 of the Compiled Statutes of the State of Wyoming of 1910 is hereby amended and re-enacted so as to read as follows: All Counties shall be divided into Road Districts. The Board of County Commissioners of each County shall divide their County into road districts of as compact form and convenient size as practicable, and embracing the Territory within an election district if possible and may change or alter said Road Districts from time to time as the public convenience may require.

Section 2. All acts and parts of acts in conflict with this act are hereby repealed.

Section 3. This act shall take effect and be in force from and after its passage.

Approved February, 22nd. 1913.
