PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS.

Board met pursuant to adjournment of May, 6th. 1913. Roll Call showing present, Robt. A. Day, D. C. Jones, Wm. A. Mc Kay, Chairman, and L. B. Magor. Clerk.

Proceedings were had as follows, to-wit:-

LICENSE .

Applications for Retail Liquor Licenses were presented for the first reading as follows:-

The matter providing for work needed to be done in the different Road Districts of the County was discussed and the following resolution was presented by Commissioner Day.

WHEREAS there has been considerable complaint in different sections of Carbon County that more monies available for highway purposes have been expended in one section than in another, and

WHEREAS the county of Carbon has been divided by the Commissioners of Carbon County into four road districts, and

WHEREAS the Commissioners deem it advisable to divide the monies in the hands of the County Treasurer for highway purposes among the said districts in proportion to the actual mileage of County highways or travelled highways in each of the said districts, and

WHEREAS at the present time the majority of the travelled highways in Carbon County have not been established as county highways, and

WHEREAS it is the purpose of the Commissioners of Carbon County to establish all travelled highways necessary for the public convenience as public highways of Carbon County as rapidly as possible, and

WHEREAS it will be impossible for the Commissioners to determine at the beginning of each year just when and where bridges over water ways will be required in the County, and more bridges will be required in some portions of the County than in others,

NOW THEREFORE, be it RESOLVED that this Board set aside in a special bridge fund one-third of the monies available each year for highways purposes, and use such monies for the bridges of the county wherever and whenever the same may be needed in the discretion of the Board, without regard to the boundaries of various road districts heretofore established, and

be it further RESOLVED that the balance of the monies remaining each year in the hands of the County Treasurer, available for highway purposes, be apportioned to the various road districts established on January 1st of each year in Carbon County in proportion to the actual mileage of county or established travelled roads in each of the road districts, and

Be it further RESOLVED THAT the Board of County Commissioners shall proceed as expeditiously as possible to establish as county highways ^{all travelled highways} in Carbon County which are

necessary for the convenience of the public, and
it

Be further RESOLVED THAT after the travelled public highways of this county are established as county roads, that no monies shall be expended upon any road Carbon County except it be upon established county roads.

Be it further RESOLVED that so far as practicable the Board shall expend no monies upon established travelled highways of Carbon County unless the Board proposes as soon as possible to establish such travelled highways as public roads of Carbon County, and

Be it further RESOLVED that no monies shall be expended upon any travelled road, which is not an established county highway, for permanent betterments, and that the only monies that shall be expended on any such road shall be merely such as are necessary to render passage for vehicles practicable; provided, however, that as soon as any such road becomes a public highway of Carbon County, that then the Board of County Commissioners shall proceed to expend monies when necessary for the permanent improvements of such road.

Moved by Commissioner Jones and Seconded by Commissioner Mc Kay this resolution be adopted and copy sent to each paper in Carbon County for Publication. Motion Carried.
