Proceedings were had as follows:

Jas. W. Sowder, Saratoga, Wyoming. Letter of 7/25/1913. Presented, considered and reduction of valuation refused.




P. R. Davis, Encampment, Wyoming. Letter 7/26/13., presented, considered and reduction was refused. Notified 7/31/13.




Chas. McKay, Saratoga, Wyoming. Letter 7/28/13. Presented, considered and permission given for future conference.



Clerk of the Board.

Alex. McPhail, Saratoga, Wyoming. Reduction asked for by phone refused on account of the valuation being less after the raise than it was previously.


