

## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS. JANUARY, 6th. 1914.

Board met this 6th. day of January A. D. 1914 at 10 o'clock A. M. in regular session as is by law required. Roll call showing present, Commissioners Robt. A. Day, Wm. A. Mc Kay Chairman, and L. B. Magor, Clerk. Commissioner D. C. Jones absent.

Proceedings were had as follows, to-wit:-

Mr. John A. Donnel appeared before the Board regarding erroneous assessment of live stock of the Donnel Sheep Co. in Dist. No. 3. and asked that a rebate be granted him for the difference in the School Levy between School Districts No. 3. and No. 14. which is the home range of said live stock. Whereupon it was moved by Commissioner Day and seconded by Commissioner Mc Kay that the above rebate be granted and tax order issued in the amount of \$108.05 which is the difference. Motion carried.

R/ The Board have decided to locate a road to connect with the County Road near Saratoga Wyoming, and Mr. C. B. Sterrett being appointed Deputy Surveyor at a meeting of the Board held Dec. 5. 1914 to make such survey and to connect such road. Mr Sterrett has made the following reports of his survey and filed his field notes. Said road being described as follows, to-wit:- Board instructed the Clerk to advertise said road as follows:-

Beginning at the intersection of the Boundary line of Section 36, with the west boundary line of the Saratoga & Encampment Railway right of way and 626 feet west of the Northeast corner of said Section 36, thence west 4676 feet, to the Northwest corner of said Section 36, thence West 421 feet south of and adjoining the north boundary line of Section 35 Township 18N. Range 84 W. to the County Road from Saratoga to Ft. Steele in Carbon County Wyoming. Thence South 10° West 60 feet along said road, thence East 424 feet to Section line between Sections 35 and 36 in said Township and Range, thence East, parallel with and 60 feet South of the North boundary line of said Section 36, 4663 feet to a point on the West line of the Saratoga, & Encampment right of way, thence North 11° 40' East 60 feet to the place of beginning being six acres and forty-three hundredths of an acre more or less in said Section 36 and fifty-six hundredths of an acre more or less in said Section 35.

Motion put by Commissioner Day and seconded by Commissioner Mc Kay that all persons in the County between the ages of 21 and 50 years inclusive, pay a Poll Tax of \$2.00 for School Purposes, according to Sec. 2320 of the Wyoming Compiled Statutes of 1910. Motion carried.

It was moved by Commissioner Day and seconded by Commissioner Mc Kay that each able-bodied man in the County between the ages of 21 and 50 years inclusive, pay a Special Road Tax of \$2.00 according to Sec. 2562 of the Wyoming Compiled Statutes of 1910. Motion carried.

County Assessor C. B. Boyce presented for approval of the Board the division of the County into Assessment Districts as follows, to-wit:

District No. 1. All of School Districts No's. 4-8-9-10-15-16-18-20-22-23-25-27-28-29-30 and 35.

District No. 2. All of School Districts No's. 1-2-3-5-6-7-11-12-14-14-17-19-21-24-31-32-33-34-and 36.

It was regularly moved and seconded that the above division of the County into assessment districts be and is hereby approved. Motion carried.

It being reported that the County Bridge at Baggs, Wyoming was badly in need of reflooring. Whereupon the Clerk was instructed to advertise a call for Bids for the reflooring of the above mentioned bridge as follows, 345 feet long and 14 feet wide

with a double floor each floor to be of 2 inch plank and to also put old floor on top.

Dr. Swisher appeared before the Board stating the County was in need of a Pest House as there were several cases of small pox in quarantine now. It was agreed that W. A. McKay would try and find a suitable site and report at the next meeting.

Bids on Bridges which were laid over from the morning session were acted on as follows: The County being unable to build all bridges necessary for the County the Board decided that the bridges most needed at the present time were the 140 foot Bridge at the Beer Mug Crossing and the bridge that was washed out last Spring about 4 miles North of Medicine Bow, Wyo. After due consideration of the bids as presented the Board found that the Missouri Bridge & Iron Co, bid on the Beer Mug Crossing Bridge was the lowest and best bid and the Colorado Bridge & Construction Co. being the lowest and best bid on the bridge about 4 miles north of Medicine Bow, Wyo. It was regularly moved by Commissioner Day and seconded by Commissioner Mc Kay that said bids be accepted upon the said above mentioned bridge companies giving bond in the amount of their bid\$ and signing Contract to insure a good and workmanlike job. Said work to be approved by the Board. The certified checks filed with the bids were ordered returned to their respective owners. Motion carried.

#### ASSIGNMENT OF TITLE.

Bid was received from Mr. R. P. Fuller for the assignment of the county's Title to Lots 5 and 6 in Block 5 in the Town of Medicine Bow, Wyoming. This property was sold to the County for 1911 and 1912 taxes. The enclosed check for \$555.76 being sufficient to pay all costs, taxes, penalties and interest on the above mentioned property it was moved by Commissioner Day and seconded by Commissioner Mc Kay that Mr. R. P. Fuller's offer be accepted and assignment made. Motion carried.
