# ASSIGNMENT OF TITLE.

At a tax sale of delinquent taxes held on July, 2, 1915, the NE $\frac{1}{4}$  of Sec. 8, in Twp. 21, N. R. 78 W. of the 6th. P. M. was sold for 1914 taxes to Carbon County, Wyoming. A bid was received from Horne Bros. Inc. for the assignment of the County's Title to the above property, the enclosed check for \$6.15 being sufficient to pay all taxes, costs, penalties and interest on the above property it was moved by Commissioner Day and seconded by Commissioner Christensen that Horne Bros. Inc. offer be accepted and assignment made, Motion carried.

One and Two, of Carbon County, Wyoming.
