Proceedings were had as follows, to-wit:-

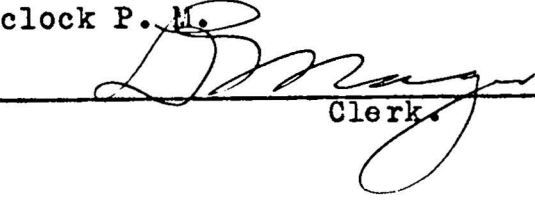
The minutes of the previous meeting were read and approved.
