PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, JANUARY 5th. 1915.

Board met at 10 o'clock A. M. this 5th. day of January A. D. 1915, in regular session as is by law required. Commissioners Robert A. Day, Ivor Christensen and Wm. A. Mc Kay being present, Wm. A. Mc Kay was chosen Chairman Pro Tem.

It was regularly moved by Commissioner Day that Chairman Pro Tem Wm. A. Mc Kay be made chairman of the Board of County Commissioners of Carbon County, Wyoming.

A delegation of tax-payers from the Platte Valley appeared before the Board and presented a petition and map of survey of proposed road which road connects the Saratoga and Brush Creek road at the Edward Ryan ranch with the Encampment Road and the west side of the North Platte River. And to also construct a bridge across the North Platte River

Owing to the petition calling for gates and no lanes to be built, the Board could not grant their request and the matter was laid over and the petition and map ordered filed.

A number of tax-payers came before the board asking that the valuations on Carbon County Lands be reduced before the 1915 assessment is made. Owing to a similar action of one of the County Boards in the State being now pending in the Courts the Board deemed it advisable to wait for this decision before making any change.

BOTT AND ROAD TAX

Regarding the matter of the collection of poll and road taxes by the Assessor at the time of assessment it was regularly moved by Commissioner Day and seconded by Commissioner Christensen that all persons between the age of twenty-one and fifty years, inclusive, pay a poll tax of two Dollars (\$2.00) for School Purposes in accordance with Section 2320 Wyoming Compiles Statutes of 1910 and also that each able bodied man in the County between the age of twenty-one and fifty years, inclusive, pay a special road tax of two dollars (\$2.00) according to Section 2562, Wyoming Compiles Statutes of 1910. Motion carried.
