Colley for the term of two years according to his bid which was as follows, to-wit:- he is to receive 50¢ per day for the board and care of each inmate and to pay to Carbon County the sum of \$200. per year for the use of the Farm upon his signing the contract and furnishing the bond of \$1000. to Carbon County, Wyoming, for the faithful performance of his duties. A bridge petition from Saratoga and one from Encampment, Wyoming, were presented to the Board signed by a number of taxpayers of Carbon County, Wyoming, petitioning the Board to erect a new bridge over the Platte River at Saratoga, Wyoming, same was ordered filed.

Owing to irregularities in the advertisement of a call for bids for the building of bridges in Carbon County that were to be opened this date the board deemed it not advisable to accept any bids at this time and instructed the clerk to re-advertise a call for bids for the building of bridges in this county as follows, to-wit:- One 80 foot steel or concrete bridge across the Medicine Bow River about 12 miles south of Medicine Bow Station; One 200 foot steel, concrete, or combination of wood and steel bridge across the Platte River near French Postoffice about 18 miles east of the town of Encampment, Wyoming; One 180 foot steel, concrete or combination of wood and steel bridge across the Encampment River near Baggott Rocks about 1 mile from Saratoga & Encampment Railroad; One 40 foot concrete or steel bridge across Cow Creek about 5 miles west of Day's Siding; One 50 foot steel or concrete bridge across Spring Creek about 3 miles south of Saratoga, Wyoming. Bidders required to file with their bids detailed plans and specifications and also certified check in the amount of 10% of their bids. Bids to filed in the County Clerk's Office at Rawlins, Wyoming, not later than 10 o'clock A. M. on March 15th. 1915.
