For Clerk of the District Court. One Person.

For County Superintendent of Schools. One Person.

For County Surveyor. One Person.

For County Coroner, One Person.

For Justice of the Peace, One Person in each Justice Precinct.

For Constable. One person in each Justice Precinct.

For Road Supervisor for Road District No. One. One Person.

For Road Supervisor for Road District No. Two. One Person.
