Commissioner Day voting aye



WHEREAS, a Petition subscribed to by the Applicant and represented by L. E. Armstrong, Practicing Attorney of Rawlins, Wyoming, and also signed by a majority of the required electors and citizens residing in the District comprising the proposed townsite of the Town of Elmo, in Carbon County, Wyoming, and containing the boundaries thereof and the quantity of land embraced therein, according to the verified survey thereof and the resident population contained therein, as shown by the verified census thereof, and also the name of the proposed town to-wit:- ELMO.

Said petition asking for the incorporation of the said town which said petition has attached thereto the affidavits of three electors verifying the facts therein alledged, which said petition had attached thereto, a verified copy of the notice given showing that the same was posted in three public places namely, viz: Workingmen's Commercial Co., John Hill's Place and the Greek Pool Hall within the limits of such proposed town and remained so posted at least twenty-one (21) days, to-wit:- from December 2nd. 1916, to December 26th. 1916 and where the verified survey, map and census could be examined, and also the date when said petition would be filed with the Board of County Commissioners of Carbon County, Wyoming, and application made thereon for the appointment of three inspectors to call an election of the qualified electors within such proposed town and the Board of County Commissioners of said County after hearing *and no one objecting then* all parties interested in such application who appeared before it, and same was referred to County ~~attorney~~ A. J. Rosier to report to the Board his opininn as to the legality of the proceedings filed and be satisfied that all requirements of Chapter 120 of the Compiled Statutes of Wyoming, 1910, relative to the incorporation of Towns within the State of Wyoming, had been fully complied with.

POLL AND ROAD TAX.

Regarding the matter of the collection of Poll and Road Taxes by the Assessor at the time of assessment, it was regularly moved by Commissioner Day and seconded by Commissioner Rasmussen that all persons between the age of Twenty-one and Fifty years, inclusive, pay a Poll Tax of Two (\$2.00) Dollars for School Purposes in accordance with Section 2320 of the Wyoming Compiled Statutes of 1910, and also that each able bodied man in the County between the age of Twenty-one and Fifty years, inclusive, pay a special road tax of Two (\$2.00) Dollars according to Section 2562, of the Wyoming Compiled Statutes of 1910, Motion carried.

The matter of estimating the cost of maintaining the County Government for the year 1917, in Compliance with Section 1132, of the Compiled Statutes of Wyoming, 1910, was considered and after due calculations apportionment was made as follows:-
