DISTRICT. NO. 1.

District No. 1, embracing all of School Districts Nos. 4, 15, 16, 27, 28, and 29.

DISTRICT. NO. 2.

District No. 2, embracing all of School Districts Nos. 3, 12, 13, 14, 17, 33 and all of the Platte Valley west of Elk Mountain and south of the Union Pacific Railroad.

DISTRICT. NO. 3.

District No. 3, embracing all # the territory of Carbon County east of Elk Mountain south of the Union Pacific Railroad and School Districts 2, 6, 7, 19, 25, 32, North of Union Pacific Railroad.

It was regularly moved and seconded that the above division of the County into assessment districts be and is hereby approved. Motion carried.

On motion duly put and carried that all grazing land lying in Carbon County west of the Range Line between Ranges 88 and 89 in the Railroad Limit be assessed at \$1.00 per acre, that heretofore had been assessed at \$1.50 per acre. Motion carried.
