Board met at 2 o'clock P. M. this 6th day of June A. D. 1916, pursuant to adjournment of morning session. Roll call showing all members present.

Proceedings were had as follows; to-wit:-

A Delegation of Citizens and Tax-Payers of Carbon County, Wyoming, appeared before the board and presented a written petition, which petition being as follows:-

To The Hon. Board of County Commissioners:
Rawlins, Carbon County, Wyo.

Gentlemen:

We the Undersigned, taxpayers of Carbon County, have this day appeared before the Board of County Commissioners and appealed to them for a thorough, careful consideration on the Meldrum Case wherein so much prejudice has appeared.

We are convinced that he can not be convicted, and in fact, the case is now changed to Laramie County to be tried, at Cheyenne, entailing great expense to this County and greatly increasing the taxes, now already burdensome, we urge and beg of the County Commissioners to decline to make further expenditure of the money of the people in this case.

We the undersigned, believe that such action, if taken by the Commissioners, will meet with the approval of the majority of the best citizens of this County.

Upon mutual understanding of the parties and the Board, the decision of the Board thereon was postponed until the following day at 10 o'clock A. M. at which time final action would be taken.

Comes now Mr. Geo. C. Austin, Superintendent of the Saratoga & Encampment Railroad, petitioning the Board to take definite action as to the matter of the rebate of the Saratoga & Encampment Railroad taxes for the year 1915, which has been before the Board for some time, stating that the company desired a rebate of the State and General County taxes only; that they had paid all the Municipal taxes and would pay all special school taxes and etc., should their rebate be granted.

It being made to appear to the Board from statements of the Company that the said company had operated at a net loss for the year 1915, it further being the opinion of the Board that it was for the best interests of the people of Carbon County, that said company continue to operate its railroad.

Upon motion by Commissioner Day and seconded by Commissioner Mc Kay and unanimously carried, that the State and County Tax be rebated in the total amount of \$2091.60. No warrant.
