Owing to the Saratoga & Encampment Railroad Co, being assessed by the County and also by the State of Wyoming, therefore the County assessment is erroneous or double. On motion duly put and carried that the valuation returned by the County Assessor of the amount of \$133,000.00, be rebated to clear same on the Treasurer's Books. No Warrant.

Mr. W. W. Daley and Mrs. G. H. Merrell came before the Board petition said Board relative to the advancement of agricultural progress, and asked that the County appropriate from the County Treasury \$900.00 per year as the County share for the salary and expenses for maintaining a County Agricultural Agent for Carbon County, provided that the State of Wyoming, through the University, appropriate \$2.00 for every one appropriated by the County of Carbon and that the Federal Department assist in supporting and maintaining the work. The above matter was laid over for the present.

A petition was received, signed by a number of tax-payers of Carbon County and residents in the vicinity of Elk Mountain, Wyo. petitioning the Board to grade and drain the road east of Elk Mountain leading out of the Medicine Bow River, as it is almost impossible to pull a load up the hill during wet weather. The Board ordered the above petition filed.
