

## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, JULY, 3rd. 1917.

Board met at 10 o'clock A. M. this 3rd day of July A. D. 1917, in regular session as is by law required. Roll call showing present, Commissioners Andrew W. Rasmussen, Wm. A. Mc Kay, Chairman and L. B. Magor, Clerk. Commissioners Robert A. Day, absent.

Proceedings were had as follows, to-wit:-

The Minutes of the previous session were read and approved.

It was regularly moved and seconded that the Board draw up Resolutions in memory of the Late Honorable Robert A. Day, Deceased.

#### R E S O L U T I O N S

The following proceedings were had before the Honorable Board of County Commissioners of Carbon County, Wyoming, this 3rd day of July, A. D. 1917.

Honorable, Robert A. Day, a member of the Board of County Commissioners of Carbon County, Wyoming, met his untimely death within this County on the 17th day of June A. D. 1917.

Honorable, Robert A. Day, was born near the Town of Medford, in the State of New Jersey, on the 15th day of April, A. D. 1861, being fifty-six years of age at the time of his death.

He came to the State of Wyoming, at the age of twenty-two years, and settled in what is commonly known as Platte Valley, in the County of Carbon, State of Wyoming, about the year 1883, where he did reside until the time of his death. By diligent and honest endeavors he became one of the most influential ranchers and stockmen within this County.

My. Day did not become directly interested in public life until the Fall of A. D. 1914, at which time his many friends persuaded him to become a candidate as a member of the Board of County Commissioners of this County. He was elected as such County Commissioner during the Fall of 1914, by a complimentary majority. He was re-elected to the same office during the Fall of 1916, and held this office until the time of his death.

It is with profound sorrow that we the members of the Board of County Commissioners of this County, chronicle the death of the Honorable, Robert A. Day. He served the people of Carbon County, faithfully, honestly and with distinction as a member of this Board. He was always careful, conscientious and courteous in all his official acts and duties, and was honorable in all his career. He was <sup>a</sup> most highly respected citizen of Carbon County and the State of Wyoming, and his loss to Carbon County, being greatly deplored by this Board as well as by the citizens of this County.

His memory will be continued to be cherished by this Board, and his official acts continue to be a fitting example to those who may be called upon to hold responsible positions in public life.

His exemplary private life, being a fitting example of good American Citizenship, and his kindness to his family during his life was notable.

This Board in behalf of the citizens of this County, does extend to the bereaved wife and family of Robert A. Day, their sympathy.

We the members of this Board do order, that the above resolutions be spread at large upon the permanent records of the proceedings of this Board.
