SALE OF PROPERTY.

BE IT RESOLVED, That whereas Lots 21 and 22 in Block 42 in the town of Grand Encampment, Carbon County, Wyoming, were sold on July 2nd. 1915, for 1914 taxes and

WHEREAS, Said property was bid in at such sale by Carbon County, and

WHEREAS, The time for redemption has expired, whereby title to said lands passed into Carbon County, and

WHEREAS, M. K. Opperman has offered to pay to Carbon to the amount of \$6.95, which amount will amply re-imburse Carbon County for all taxes, costs, penalties and interest incurred to date.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said M. K. Opperman for the sum of \$6.95 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said M. K. Opperman.

The property of the Wyoming Consolidated Copper Co. described as the Bonanza Claim Nos. 1, 2, 3, 4, 5, 6, located in School District No. 10, was sold to Carbon County in the year 1907. The owner of said property Mr. Brackley Shaw of Brookline. Mass, being dead, the matter was taken up with the Administrator of the Estate, whereupon the administrator tendered check of \$32.73, which will cover the fee for the redemption certificate and sale price, claiming there should be no interest collected on account of

not receiving an notice of taxes.

The Board after due consideration on motion duly put and carried, agreed to accept said offer and instructed the County Treasurer to issue Redemption Certificate for the same.

Whereas, the appointment of a County Commissioner of Carbon County, Wyoming, to fill the vacancy in the Board of County Commissioners heretofore existing, caused by the death of Hon. Robert A. Day, and the action hereintaken at the regular meeting, held September 6th. 1917, no appointment being made; The matter of the appointment of a County Commissioner to fill the vacancy occurring in the Board as the result of the death of Mr. Day, was again considered by the Board on this day.

Whereupon, on motion by Commissioner Wm. A. Mc Kay and seconded by Commissioner Andrew W. Ra smussen, and unanimously carried by the Board, that Mr. D. E. Winsor of Carbon County, Wyoming, a qualified person, be and he is hereby appointed County Commissioner of Carbon County, Wyoming, to fill the vacancy in the Board of County Commissioners by reason of the death of Mr. Day, until the 1st day of January, succeeding the next general election after said appointment, upon the said D. E. Winsor qualifying as provided by law for County Commissioners to qualify.

Whereupon the said D. E. Winsor presented to the Board his Bond as such County Commissioner, said Bond being this day approved and ordered filed, took his oath of office and otherwise duly qualified as by law required.
