Board met at 2 o'clock P. M. this 8th day of November A. D. 1917, pursuant to adjournment of morning session. Roll call showing all members present.

Proceedings were had as follows, to-wit:-

-R-E-S-O-L-U-T-I-O-N-

WHEREAS regular application has been made to the State Highway Department for the improvement of the Baggs-Wamsutter Road, therefore,

BE IT RESOLVED by the Board of Commissioners of Carbon County, acting as duly qualified officials, that the sum of \$350.00 be appropriated from the road and bridge fund to pay one-half the estimated cost of the surveys to be made by the State Highway Engineer, and

BE IT FURTHER RESOLVED that the sum of \$2500.00 be appropriated from the road and bridge fund to pay one-half the estimated cost of construction of said road, the Baggs-Wamsutter Road, as shown on Federal Aid Project statement, and in case the cost of construction exceeds the estimated amount due to increased costs of materials and labor or for other contingencies, we pledge ourselves and the County to make available additional amounts up to \$500.00, to pay all costs above the estimated costs of construction necessary to complete the improvement as shown on the plans, and

BE IT FURTHER RESOLVED that the above amounts be set aside as a special fund to be known as the Baggs-Wamsutter Road Fund, payments to be made from this fund upon vouchers presented by the State Highway Department, and

BE IT FURTHER RESOLVED that if the improvement of the Baggs-Wamsutter Road be approved by the Secretary of Agriculture and an allotment of Federal Funds be made by said Secretary for this project, we as duly elected and qualified officials of Carbon County and acting in an official capacity do hereby pledge ourselves to obtain and

and secure, in a legal manner, such right-of-way for said road as may be necessary and required by the alignment and grade, this width, wherever possible, to be not less than 40 feet on each side of the proposed center line of construction and if less than 40 feet on either side of said center line, in no case shall it be less than that which will be necessary for the proper slopes of banks in either cuts or fills.
