

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, DECEMBER 4th. 1917.

Board met at 10 o'clock A. M. this 4th day of December A. D. 1917, in regular session as is by law required. Roll call showing present, Commissioners D. E. Winsor, Andrew W. Rasmussen & Wm. A. Mc Kay. Chairman and L. B. Magor, Clerk.

Proceedings were had as follows, to-wit:-

. The Minutes of the previous session were read and approved.

. Miss Hazel Colley of Dixon, Wyoming, who is in charge of the Poor Farm at Dixon, came before the Board asking for a raise of 25¢ per day for board and care of each inmate at the County Farm, stating that the present prices of food stuffs it is impossible to properly feed and care for the inmates at the present allowance.

On motion by Commissioner Rasmussen and seconded by Commissioner Winsor, that Miss Colley be allowed the raise of 25¢ additional, per day, for each inmate, same to take effect and be in force from and after December 1st, A. D. 1917, during the continuance of the present contract for the care of the Poor Farm. Motion carried.

Mr. Captain Charles Wanzer, from Union Pacific Headquarters at Omaha and Mr. C. E. Adams Jr. Right of Way Agent of the Union Pacific at Denver, Colo, appeared before the Board relative to all County Roads touching the Right-of-way of the Union Pacific Railroad Company in Carbon County. Maps submitted and lease requested of all roads touching such right-of-way from the Union Pacific Railroad Co. to Carbon County, Wyoming.
