

The reports of Justices of the Peace Jno. C. Friend, P. P. Murhy, and Edw. Mc Atee, County Treasurer E. M. Tierney, were read and ordered filed.

A petition was received by the Board signed by a numbere of Jurymen, who acted as Jurors in the last term of the District Court, urging and requesting that the officials of Carbon County, arrange differently or upholster the chairs that they now have in the Jury Box so that the Jurymen can be more confortable when serving on cases. The petition was also recommended and approved by the Judge. The same was read and ordered filed.

A communication was received signed by Aden & Reinholtz, John Swanson and J. E. Nelson wherin they state that in 1916, they signed a petition asking for a County Road up Spring Creek the County to Fence same and to put in Subways, but since that time they have carefully considered this road and in the event that the road does not go the full length of the creek and ask that their petition of 1916 be set aside. so we hereby ask that your honora ble Board put in thas road without having it fenced or having subways put in and have same made outside of the ranches. Same was ordered laid over for the present.

Board met at 2 o'clock P. M. this 7th day of March, A. D. 1917, pursuant to adjournment of morning session. Roll call showing all members present.

Proceedings were had as follows, to-wit:-

Communication from Mr. C. C. Dolan of Dixon to the Board of County Commissioners was read relative to the building of a bridge across Sanke River stating that they has already made a grade from the main Dixon, Savery Road to the river a distance of about one mile and also they were prepared to put in fill at each approach of bridge and do anything else necessary to make the road passable, the span of the bridge would be 120 feet. The Board of Commissioners could not state what action would be taken so ordered the petition filed.

BE IT RESOLVED, That whereas lot 19 in Block 131 was sold for taxes on June 13, 1906 for 1905 taxes and on July. 10. 1908 for 1907 taxes, Lots 20 and 21 in Block 131 was sold for taxes on June. 24. 1912 for 1911 taxes, and Lots 22, 23 and 24, in Block 131 was sold for taxes on June 30. 1911. for 1910 taxes, situate in the town of Grand Encampment, Carbon County, Wyoming, and

WHEREAS, Said property was bid in by Carbon County at such sales, and
