Proceedings were had as follows, to-wit:-

SALE OF PROPERTY:

BE IT RESOLVED, That whereas Lot 17 in Block 28 in the town of Grand Encampment, Carbon County, Wyoming, was sold for taxes on June, 30th. 1911 and June, 27, 1913, for 1910 and 1912 taxes, and

WHEREAS, Said property was bid in at such sale by Carbon County, and

WHEREAS, The time fore redemption has expired, whereby title ^{to said property /} passed into Carbon County, and

WHEREAS, RILEY F. BOYD has offered to pay to Carbon County, to the amount of \$10.13, for said property, which amount will amply re-imburse Carbon County, for all taxes, penalties, intestest and costs incurred to date.

CALL FOR BIDS.
