Board met at 10 o'clock A. M. this 8th day of October A. D. 1918, in regular session as is by law required. Roll call showing present, Commissioners D. E. Winsor, A. W. Rasmussen, Wm. A. Mc Kay, Chairman and L. B. Magor, Clerk,

Comes now, A. Mc Micken, Attorney for the Union Pacific Coal Company and shows to the staisfaction of the Board that it is engaged in the operation of mining in said County, and requests for that purpose permission to store at places which it has provided for that purpose not less than the number of pounds of powder each day, to be used in blasting operations in each of its mines, to-wit: #2 Mine, #3 Mine and #4 Mine, the said amount constituting about one day's supply of powder for each of its said mines.

And upon said application the said Board now orders that permission be given to the said Company to store the amount of powder aforesaid for the purpose aforesaid and at the places aforesaid.
