Regarding the letting of the Contract for the construction of a steel bridge at or near the Dolan Ranch across Snake River was brought before the Board. The Board having taken this matter up with the Board of Council of National Defense, said Board denying the Board of County Commissioners permission to build such bridge under the present conditions.

Upon motion duly made by Commissioner Winsor and seconded by Commissioner Rasmussen and unanimously carried by the Board, the sum of \$5000.00 be and the same is hereby authorized to be appropriated from the Road & Bridge Fund of this County for the year 1919, for the construction of a proposed County Road on the old abandoned Union Pacific Railroad Grade between Allen Junction and Old Dana, Carbon County, Wyoming. Said sum to be used in conjunction with a like sum to be donated by the Lincoln Highway Association. All of said Money to be used solely upon the construction of said proposed County Road.
