The $\frac{1}{2}$ of the $\frac{1}{4}$ of Sec. 14, Twp. 28. N. R. 81 was assessed for the years 1910, 1911, 1912, 1913, 1914, 1915 and 1916, in the name of Ed. O'Brien, and sold at the delinquent tax sale held in 1915 to The Glen Investment Co, and Certificate of Purchase No. 159 was issued to said Company on receipt of the purchase price, viz: \$26.11, and in the year 1916 it was again sold to The Glen Investment Co and certificate of Purchase No. 194 was issued to said company on receipt of the purchase price, viz: \$11.19.

In the year 1917 it was sold to C. J. Faehndrick and Certificate of Purchase No. 214 was issued to him on receipt of the Purchase price, viz: \$10.88.

Application for a refund of these amounts is now made by the above named parties under the provisions of Section 2436 Wyoming Compiled Statutes of Wyoming 1910, entitled COUNTY TO INDEMNIFY PURCHASED WHEN SALE UNLAWFUL, in consequence of the title to the above described property not being in the name of said Ed. O'Brien.

The above statement regarding title being corroborated by the Register of the U. S. Land Office, Cheyenne, Wyo. under date of February 4th. 1918, the County Treasurer is hereby intrusted to redeem the above Certificates of Purchase and present his claim to this Board for a warrant to cover the amount so refunded.

Sheriff M. E. Pickett, presented to the Board the appointment of Mr. Steve Harl as Deputy Sheriff for the Hanna Precinct. Whereupon it was moved by Commissioner

Winsor and seconded by Commissioner Rasmussen that the above appointment be confirmed subject to the pleasure of the Board. Motion carried.

In the year 1908 the SE $\frac{1}{4}$ of Sec. 10, the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Sec. 14, and the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 15. in Twp. 26. N. R. 88 W. were assessed to Wm. Hayes and sold to the County at a delinquent sale held July. 15. 1909. and has not been redeemed.

The SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Sec. 10, and the other property above described, have since been sold to John Mahoney, and he has expressed a willingness to pay the taxes as levied so as to clear his title on the records of the County Treasurer.

The hearing in regard to the liquor licenses Applications of Thomas D. Mangan and Fred Williams of the town of Elmo, Wyoming, was again taken up by the Board.

Personally appeared before the Board at this time A. R. Mc Macken, Esq. S. D. Briggs, I. Christensen, R. L. Bedford, Edw. Mc Atee, Dr. Hammond, Otto Frederick, Geo. E. Brimmer, Geo. A. Bible and A. J. Rosier, Esq. residents of Carbon County, Wyoming, made protests against the issuing of said liquor licenses to Thos. D. Mangan and Fred Williams at Elmo, Wyoming.

Mr. L. E. Armstrong, appearing personally before the Board in behalf of each of said applicants.

The Board then went into Executive Session for the purpose of considering the said protests of the various parties who had appeared before this Board against the granting of a saloon license upon the application of the said Thos. D. Mangan and the said Fred Williams to conduct saloons at the town of Elmo, in Carbon County, Wyoming, at the premises designated and set forth in each of their applications for license on file herein. This meeting being the second regular meeting of the Board occurring subsequent

to the filing of the said applications for a liquor license as aforesaid on the part of the said Thos. D. Mangan and Fred Williams.

The Board having duly considered all of the evidence introduced before it and being advised as to the law in the premises, the following resolution being unanimously adopted by the Board.

BE IT RESOLVED, By the Board of County Commissioners of Carbon County, Wyoming, that the said application of Thos. D. Mangan for a liquor license to conduct a saloon at the said Town of Elmo in Said County in accordance with said application of the said Thos. D. Mangan be and the same is hereby refused and denied.

Roll call of vote upon said Resolution, Commissioners Rasmussen, Commissioner Winsor and Commissioner Mc Kay all voting aye. Resolution unanimously adopted.

The following resolution was unanimously adopted by the Board.

BE IT RESOLVED, By the Board of County Commissioners of Carbon County, Wyoming, that the said application of Fred Williams for a liquor license to conduct a saloon at the Town of Elmo in said County in accordance with said application of the said Fred Williams be and the same is hereby refused and denied.
