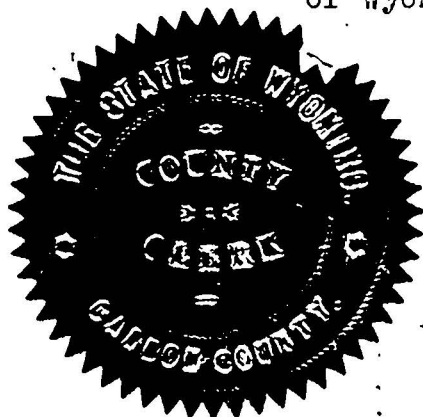

BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING.
TO THE QUALIFIED VOTERS OF CARBON COUNTY, STATE OF WYOMING. TAKE NOTICE.
NOTICE is hereby given, that pursuant to a Proclamation issued by his Excellency ROBERT D. CAREY, Governor of the State of Wyoming, dated the 28th day of February A. D. 1919, a SPECIAL ELECTION will be held in the several voting precincts of the County of Carbon, State of Wyoming, on Tuesday, the 22nd day of April A. D. 1919, at which time and date there shall be submitted to the qualified voters of Carbon County, State of Wyoming, the following question.

"Shall the State of Wyoming issue its coupon interest bearing bond in the sum of two million eight hundred thousand dollars to be designated as highway bonds in denominations of five hundred, one thousand, five thousand and ten thousand dollars, redeemable at the option of the State of Wyoming ten years after date thereof and payable in twenty years after date thereof, bearing such rate of interest, not to exceed five per centum per annum from date until paid and to be issued in such amounts as the Governor and Treasurer of the State of Wyoming shall determine ? "
