Mr. H. D. Elydenburgh appeared before the Board in behalf of a petition heretofore filed for the establishment of a County Road, as follows:- to-wit:-

"Commencing at the County Road as it turns north through Jack Creek Lane, at the southwest corner of Section 9, Township 17, N. R. 84 W. of the 6th. P. M, thence westerly through the North Half of Section 18, Township 17, N. R. 84 W., thence westerly through the North Half of Section 13, Township 17, N. R. 85 W. to the South side of the Northeast quarter of the Northeast quarter of Section 14, Township 17, N. R. 85 W. to the gate of the Jack Creek Land & Cattle Co's. Ranch; continuing from the forks of said road east of the Jack Creek Land & Cattle Co's. said gate southwesterly to the ranch of Louis Seaverson in Section 31, Township 17, N. R. 85 W."

After due consideration, it was moved by Commissioner Wood and seconded by Commissioner Rasmussen and unanimously carried by the Board, that the County Surveyor Mr. J. W. Wisda, is hereby directed to make an official survey of said proposed road and to prepare a map thereof and that said map be presented to this Board as soon as completed.
