Road A delegation of tax-payers from Encampment and Spring Creek appeared before the Board and filed a petition desiring the completion of a road running through the Huston Ranch connecting with the road already built from Encampment to the Huston Ranch on the east with the road already built running from the Huston Ranch to Saratoga on the west, in Carbon County, Wyoming, and also presented Resolutions passed at a Mass Meeting held in the Town of Encampment, Wyoming, on August 2, A. D. 1919.

The Board ^{took} ~~took~~ the petition and resolutions of establishing said road under advisement with the understanding that the Board would investigate the particular portions of said road desired to be constructed or established within the near future to ascertain the feasibility of condemnation proceedings or to otherwise acquire title in the County to that portion of the road desired to be constructed.

SNAKE RIVER BRIDGE.

Bridge That on the 8th day of November A. D. 1918, the bid of the Colorado Bridge & Construction Co. to construct a bridge across Snake River at or near the Dolan Ranch in Carbon County, Wyoming, according to plans and specifications filed with the Board, was by ~~this~~ the Board on this day accepted at the price bid by said Company and the Chairman of the Board, attested by the Clerk of said Board is hereby duly authorized and directed by the unanimous consent of the Board to execute and deliver a contract with said Company in conformity to its bid heretofore filed with the Board. All war restrictions as to improvements having been removed.
