#### SALE OF PROPERTY.

An error having occurred in the application for Commissioner's Deed for Lot 6 in Block 8 in the Town of Yoakum, now a part of the Town of Baggs, wherein the name of the purchaser ~~was~~ W. H. Burton should have been T. B. Vernon, the party offering the sum of \$21.72 for said property; and said error having been brought before the Board, with request that said deed be cancelled and new one issued to the proper party. After examination it was found said deed was issued in error ~~and~~ whereupon it was moved by Commissioner Wood and seconded ~~that~~ by Commissioner Rasmussen, that the Commissioner's Deed issued on Sept. 3. 1919, to W. H. Burton for Lot 6 in Block 8 in the Town of Yoakum, now incorporated in the Town of Baggs, is hereby declared void and the Clerk is hereby instructed to cancel same and the County Treasurer is hereby instructed to refund the sum of \$21.72, the amount paid for said lot, to the proper parties.

WHEREAS, Said property was bid in at such sale by Carbon County, and

WHEREAS, The time for redemption has expired whereby title to said property passed into Carbon County, and

WHEREAS, T. B. VERNON has offered to pay to Carbon County to the amount of \$21.72, which amount will amply reimburse Carbon County for all taxes, interest, costs and penalties incurred to date.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said T. B. VERNON for the sum of \$21.72 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said T. B. VERNON.

There being no further business coming before the Board it was moved by Commissioner Wood and seconded by Commissioner Rasmussen that the meeting adjourn to meet again in Regular Session on November 4th. A. D. 1919. Motion carried.
