

Board met at 10 o'clock A. M. this 4th day of December A. D. 1919, pursuant to adjournment of December 3rd 1919. Roll call showing present, Commissioners R. T. Wood, A. W. Rasmussen, Wm. A. Mc Kay, Chairman and R. A. Magor, Clerk.

Proceedings were had as follows, to-wit:-

ENCAMPMENT-SLATER ROAD.

Application having heretofore been made by Citizens and Tax-Payers residing in the vicinity of Encampment, Carbon County, Wyoming, for an appropriation of money by Carbon County, Wyoming, in conjunction with an appropriation of money to be appropriated by the United States Government in the construction of a portion of the road running through the Hayden National Forest Reserve, known as the Encampment-Slater Road, and it appearing to the Board that it would be for the interests of the residents of the southern portion of Carbon County that such road be constructed as aforesaid.

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of Carbon County, Wyoming, that the sum of Twelve Thousand (\$12,000.00) Dollars be appropriated out of the proper funds of Carbon County, Wyoming, to be used in conjunction with the monies appropriated therefor by the United States Government, according to the specifications to be outlined by said Government.

Said sum of Twelve Thousand (\$12,000.00) Dollars to be payable to the proper officers or agents of the United States Government, on demand, as follows to-wit:- the sum of Six Thousand (\$6,000.00) Dollars thereof to be due and payable during the year A. D. 1921 and the sum of Six Thousand (\$6,000.00) Dollars thereof to be due and payable during the year A. D. 1922.

ROLL CALL OF VOTE: Commissioners Rasmussen, Mc Kay and ~~Wood~~ all voting AYE.

Mr. S. Park, County Treasurer, notified the Board that the sale of Lot 10 in Block 101, in the Town of Encampment, Wyoming, which was held on July, 13. 1906, for 1905 taxes, was erroneous and the present owner Mr. Aug. G. Anderson, claims that payment of the above was made but in some manner proper credit was not made, whereupon it was moved by Commissioner Rasmussen and seconded by Commissioner Wood that the sale of Lot 10 in Block 101 in the Town of Encampment, Carbon County, Wyoming, held on July, 13th. 1906, be and the same is hereby annulled in order to clear the records. Motion carried.
