

## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, SEPTEMBER, 9th. 1919.

Board met at 10 o'clock A. M. this 9th day of September A. D. 1919, in Special Session for the purposes of making the levy for the requisite taxes upon the assessed and taxable property within the County for the year A. D. 1919.

Roll call showing present, Commissioners R. T. Wood, Wm. A. Mc Kay, Chairman and R. A. Magor, Clerk. Commissioners A. W. Rasmussen being absent.

Proceedings were had as follows, to-wit:-

The Board proceeded to make the levy for the requisite taxes upon the assessed and taxable property within the County of Carbon, State of Wyoming, for the State, County, City and School Revenue for the year A. D. 1919, as is provided by law.

The statement of the State Board of Equalization was presented, read and ordered filed.

The County Assessor submitted the certified statement from the State Board of Equalization of the State of Wyoming, showing the assessment of said County of Carbon, as made by the State Board of Equalization for the year A. D. 1919, and the properties of Corporations, Railroad, Car and Telegraph Lines as hereinafter set forth, and the County Assessor is hereby instructed to add the amounts returned by the State Board of Equalization, to the assessments of Carbon County for the year A. D. 1919, the same being a total as follows:-

At the meeting of the State Board of Equalization the rate of levy upon each Dollar of valuation for State Purposes for the year A. D. 1919, was fixed at Three and Fifty-six hundredths mills (\$.00356) and the Board were thereby directed to make this levy as provided by law.

The amount of State Tax xcharged to Carbon County, Wyoming, for the year A. D. 1919, is \$84,981.40.

It is hereby ordered by the Board of County Commissioners that the following amount be levied and assessed upon each and every dollar of taxable real and personal property in said Carbon County, State of Wyoming, and upon the assessed valuation thereof as is shown by the assessment roll of Carbon County, State of Wyoming, for the year A. D. 1919, including the valuation of property of railroad, car and telegraph companies as assessed to them by the State Board of Equalization.
