RESOLUTION.

It appearing to the satisfaction of the Board that the various Deputy Sheriffs heretofore appointed throughout Carbon County are being paid a monthly salary larger than they deem necessary for the work performed by said deputy sheriffs and in order to reduce the expenses of this County, the following resolution was unanimously adopted by the Board.

RESOLVED, that that portion of Carbon County, Wyoming, known as the Snake River Valley shall be allowed the sum of Fifty (\$50.00) Dollars per month for Deputy Sheriffs; this sum to be payable to two deputies one to reside at Baggs and One to reside at Dixon; each to receive Twenty-five (\$25.00) Dollars per month.

RESOLVED, That that portion of Carbon County, Wyoming, known as the Platte Valley shall be allowed the sum of Fifty (\$50.00) Dollars per month for Deputy Sheriffs; this sum to be payable to two Deputies one to reside at Saratoga and one to reside at Encampment; each to receive Twenty-five (\$25.00) Dollars per month.

RESOLVED, That the Deputy Sheriff appointed for Medicine Bow and the immediate vicinity shall receive a monthly salary of Twenty-five (\$25.00) Dollars per month.

RESOLVED, That this resolution reducing salaries of Deputy Sheriffs shall take effect and be in force from and after January, 1st. A. D. 1920.

Roll call of vote: Commissioners Wood, Rasmussen and Mc Kay all voting aye".

Resolution declared adopted.

There being no further business coming before the Board it was moved by Commissioner Wood and seconded by Commissioner Rasmussen that the meeting adjourn to meet again in regular session on January, 6th. 1920, as is by law provided. Motion carried.
