OF BOND ISSUE AND SALE BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING.

PUBLIC NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Carbon County, in the State of Wyoming, intends to issue, negotiate and sell the negotiable coupon bonds of said county in the amount of \$100,000. for the purpose of providing funds for the construction, acquisition and equipment of a county hospital in and for said County, as provided by Chapter 89 of the Session Laws of Wyoming 1919.

Said bonds will bear date the 1st day of April, A. D., 1920, will be absolutely due and payable twenty (20) years from the date thereof, and will be redeemable one-tenth

(1/10) annually commencing with the year A. D., 1930; said bonds will consist of one hundred (100) bonds, in the denomination of One Thousand Dollars (\$1,000) each, and will bear interest at the rate of six per cent (6%) per annum, interest to be paid on said bonds on the 1st day of April and the 1st day of October in each year, both principal and interest payable at the National Bank of Commerce in the city of New York, U. S. A.

The Board of County Commissioners of Carbon County, Wyoming, invites bids for said bonds, and all bids shall be sent to the Clerk of the Board of County Commissioners, at Rawlins, Wyoming, on or before the 24th day of June A. D., 1920, at the hour of 11 o'clock, A. M. Said Board reserves the right to reject any and all bids offered.

No conditional bids for said bonds will be considered, and as the bonds will be ready for delivery bidders must satisfy themselves as to the legality of said issue and must satisfy the said Board of County Commissioners of their ability to take up and pay for said bonds on the date of sale before their bids will be considered. The approving opinion of A. J. Rasier, Esq., County Attorney for Carbon County, Wyoming, and the approving opinion of H. F. Collins, Esq., of Denver, Colorado, will be furnished.

All bids other than bids submitted by the State of Wyoming, are to be accompanied by an unconditional certified check for Ten Thousand Dollars (\$10,000), drawn on a National Bank in the state of Wyoming, which check is to be forfeited in case such bidder refuses to comply with the terms of this notice.

After ascertaining the best terms upon which said bonds can be negotiated, the bonds will be sold for cash, in no case for less than their face or par value and accrued interest thereon to the time of their delivery by the County Treasurer under the general supervision of the Board of County Commissioners of said county.
