CALL FOR BIDS.

It appearing to the Board that it is necessary at this time to advertise for proposals or bids for the construction of the Carbon County Hospital. Upon motion made by Commissioner R. T. Wood and seconded by Commissioner A. W. Rasmussen and carried by the Board, the Clerk of this Board was authorized and directed to cause to be published, in the Rawlins Republican at Rawlins, Wyoming, and in the Wyoming Tribune at Cheyenne, Wyoming, for four consecutive weeks, the following Notice, to-wit:-

NOTICE TO CONTRACTORS.

Sealed proposals will be received by the Board of County Commissioners of Carbon County, Wyoming, for the erection of a new Hospital Building at Rawlins, Wyoming, according to the plans and specifications prepared by Baerresen & Porter, Architects, Cheyenne, Wyoming.

Proposals will be received by the County Clerk at the Court House at Rawlins, Wyo. up to 2 P. M. June, 24th. 1920, and then opened by the Board. A certified check of \$1500.00 made payable to the Board of County Commissioners of Carbon County, Wyoming, <sup>shall</sup> be tendered with proposal, or otherwise proposal will not be considered. A surety bond for the ~~full~~ amount of the contract shall be furnished before contract is signed. Plans and specifications can be seen at the County Clerk's Office or at the office of said architects in Cheyenne. If plans <sup>and specifications</sup> are removed from either of the above names offices, a cash deposit of \$150.00 shall be left as security for their safe return. Proposals shall be made out in duplicate and on blanks furnished by the Architects or the County Clerk. The County Commissioners reserve the right to accept or reject any or all proposals. <sup>There being no further business coming before the Board it was regularly moved and seconded that the meeting adjourn.
