ROAD PETITION.

The Dorsey M. Kerr, appeared before the Board and presented the following petition to-wit:-

We the undersigned tax payers of Carbon County, State of Wyoming, do hereby petition you to open a road through Sections Nine (9) Ten (10) and Two (2) Township Twenty Two (22) North of Range Seventy Eight (78) West Principal Meridian, from the town of Medicine Bow to the Ware Land and Livestock Co. ranch east of town, the way it now runs, to put in shutles for cars to pass over or to do away with all gates on said road.

Said petition being signed by a number of tax-payers of Medicine Bow and vicinity.

After due consideration, the Board instructed the County Surveyor Mr. J. W. Wisda to survey said road and to present his field notes and map at the next meeting of the Board at which time they would take action on said road.

A petition was received, signed by a number of residents and tax-payers of the Upper Snake River Valley, petitioning the Board to have the road between the O. C. Sheehan Ranch and the Muddy Bridge completed along the survey made by Mr. Wisda, the County Surveyor in 1916.

It was moved by Commissioner Rasmussen and seconded by Commissioner Wood that this road be completed, provided the cost did not exceed Five Hundred (\$500.00) Dollars, Motion carried.
