Board met at 2 o'clock P. M. this 8th day of September A. D. 1920, pursuant to adjournment of morning session. Roll call showing present, Commissioners R. T. Wood and A. W. Rasmussen and R. A. Major, Clerk. Commissioner Wm. A. McKay, absent, In the absence of Chairman McKay, Commissioner A. W. Rasmussen was chosen Chairman Pro Tem.

Proceedings were had as follows, to-wit:-

Mr. Geo. A. Bible, Treasurer of the Board of Trustees of the County Memorial Hospital, of Carbon County, Wyoming, appeared before the board, asking that the funds received from the sale of the County Memorial Hospital Bonds be transferred to him as said Treasurer, in compliance with the opinion rendered by the Attorney General of the State of Wyoming; said opinion being as follows, to-wit:-

"We find that Chapter 88 of the laws of 1917 was amended by Chapter 89, of the laws of 1919, by reducing the amount of guaranteed donations from \$50,000.00 to \$15,000.00. We also find that by the Act of 1919, Counties were enabled to incur an indebtedness for hospital purposes in the manner provided by law, for the creation of an indebtedness for Court House and jail purposes. The fund created by the sale of hospital bonds thereby becomes particularly and peculiarly the fund of the County Hospital, or in other words, the County Hospital Fund, the disposition of which is provided for as we have heretofore seen by Section 3, of Chapter 88 of the laws of 1917. Upon the sale of the bonds, which is a County Security, the money produced therefrom is covered into the Treasury of the County, and is under the direction and control of the County Treasurer until such times as the proper officer designated by law possesses the qualifications to receive and receipt for said funds. In this case, he would be the Treasurer of the Board of Trustees of the Memorial Hospital of County, and upon his tendering his receipt for the funds for the Memorial Hospital fund of County, to the treasurer of the said County, he is entitled to receive the said fund and dominate the same under the direction of the Board of Trustees of said Hospital."

Pursuant to the above opinion of the Attorney General of the State of Wyoming, the following resolution was unanimously adopted by the Board, that heretofore the Board of County Commissioners, pursuant to law, did appoint a Board of Trustees to construct, equip and acquire a Memorial Hospital for Carbon County, Wyoming, known as the "Board of Trustees of the Memorial Hospital of Carbon County, Wyoming." and,

WHEREAS, It appearing to the Board of County Commissioners that said Board of Trustees has duly organized, by the election of its officers, as provided by law, and

WHEREAS, it being made to appear that Mr. George A. Bible, of Rawlins, Wyoming, is now the duly appointed, qualified and acting treasurer of said Board of Trustees above mentioned, and

WHEREAS, the said George A. Bible has filed with this Board a bond of indemnity in the sum of \$40,000.00, being the amount ordered by this Board and same has been approved by the Board, and

WHEREAS, the said George A. Bible, Treasurer, has filed with this Board a receipt for \$100,277.77 (being the amount of the face value of said bonds plus the interest accrued on the deposit of same).

NOW THEREFORE BE IT RESOLVED, That it is ordered, pursuant to the opinion of the Attorney General above quoted, as to the law herein, that a warrant be drawn by the Board of County Commissioners of Carbon County, Wyoming, in the amount of \$100,277.77 against the "COUNTY MEMORIAL HOSPITAL FUND", now in the hands of the County Treasurer, payable to the order of Geo. A. Bible, Treasurer of the Board of Trustees of the Carbon County Memorial Hospital, and that the Treasurer of Carbon County, Wyoming, is hereby instructed and ordered to pay such warrant to said Geo. A. Bible on presentation, when accompanied by a receipt therefor as above mentioned.

Order and Proclamation for General Election.

By the Board of County Commissioners of Carbon County, State of Wyoming.

TO THE VOTERS OF CARBON COUNTY, STATE OF WYOMING.

NOTICE IS HEREBY GIVEN:

In accordance with the provisions of Chapter 97, Session Laws of 1921 approved February 21, 1921, and the proclamation of the Governor of the State of Wyoming, dated March 5, 1921, and a resolution of the Board of County Commissioners under the provisions of Chapter 67, Session Laws of 1921, approved February 17, 1921, public notice is hereby given that a special election will be held in the several election precincts of Carbon County, Wyoming on Tuesday, May 10, 1921, for the purpose of submitting to the electors of said County the following questions:

"Shall the State of Wyoming create a state debt through the issuance of bonds of the state for the construction and improvement of public roads and issue its coupon interest bearing bonds in the sum of one million eight hundred thousand dollars (\$1,800,000.00) said bonds to be designated as Highway Bonds and to be of the denomination of Five Hundred (500.00) dollars, one thousand dollars (\$1,000), five thousand (\$5,000.00) dollars and ten thousand dollars (\$10,000.00) respectively, due and payable twenty (20) years, after the date thereof and redeemable at the option of the State Ten (10) years after the date thereof, bearing interest at the rate of five (5) per cent per annum from date until paid."

The ballots to be used at said Special Election shall be as follows: The above questions shall be set out in full, under which shall follow the words, "For Highway Bonds" and "Against Highway Bonds," there shall be a square following each of the said above quoted words within which the voter may place an (X) to designate his preference.

All persons who registered during the registration period for the election of 1920 and all who can qualify as to residence but not registered can vote at this special election. The laws governing registration and elections shall apply to this special election.
