VOTING PRECINCT.

A petition was received signed by Forty-five electors of Rockdale Precinct asking that a voting precinct be established at what is known as the Ohio Oil Camp, situated in Carbon County, Wyoming.

The Board after due consideration and examination found that if this precinct was established that there would not be enough electors to hold an election at what is known as Arlington, whereupon it was moved by Commissioner Wood and seconded by Commissioner Rasmussen that the voting place of Rockdale Precinct No. 1, Election

District No. 8, Carbon County, Wyoming, be changed from the Arlington Postoffice, in said precinct, to what is known as the Ohio Oil Camp, in said precinct and all qualified electors of Rockdale Precinct No. 1, Election District No. 8, shall vote at the Ohio Oil Camp instead of the Arlington Post Office.

Roll call of vote:- Commissioners H. T. Wood and A. W. Rasmussen both voting "Aye" Commissioner Wm. A. Mc Kay, absent and not voting.

There being no further business coming before the meeting, it was regularly moved, seconded and carried that the meeting adjourn to meet again in regular session on October 5th. 1920.
