

## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, JANUARY, 6th. 1920.

Board met at 10 o'clock A. M. this 6th day of January A. D. 1920, in regular session as is by law required. Roll call showing present; Commissioners R. T. Wood, A. W. Rasmussen, Wm. A. Mc Kay, Chairman and R. A. Magor, Clerk.

Proceedings were had as follows, to-wit:-

*Recd* The Minutes of the previous session were read and approved.

Mr. C. A. Richards and Mr. Dorsey M. Kerr appeared before the Board and presented a petition in behalf of themselves and twenty other citizens and tax-payers living in the vicinity of Medicine Bow, petitioning the Board to declare and open that certain road as follows:- That certain road leaving Medicine Bow Station and running east to the ranch House of the Ware Land & Live Stock Co.

Said petition was considered by the Board and same was referred to Mr. A. J. Rosier the County Attorney.

The petition of Mrs. Kate Rivi of Hanna, Wyoming, asking for Widow's County aid was presented to the Board; said petition was referred to Mr. A. W. Rasmussen for investigation, he to report on same at the next regular meeting of the Board.

The petition of Mrs. Helen Mc Atee of Rawlins, Wyoming, asking for Widow's County aid was presented to the Board, Said petition was referred to Wm. A. Mc Kay for investigation, he to report on same at the next regular meeting of the Board.

Proceedings were had as follows, to - wit:-

## POLL AND ROAD TAX.

Regarding the matter of the collection of Poll and Road Taxes by the Assessor at the time of assessment, it was regularly moved by Commissioner Rasmussen and seconded by Commissioner Wood that all persons between the age of twenty-one and fifty years, inclusive, pay ~~xxx~~ a Poll Tax of Two (\$2.00) Dollars for School Purposes in accordance with Section 2320 of the Wyoming Compiled Statutes of 1910, and also that each able-bodied man in the County between the age of Twenty-one and Fifty years, inclusive, pay a special Road Tax of Two (\$2.00) Dollars according to Section 2562 of the Wyoming Compiled Statutes of 1910. Motion carried.

The matter of estimating the cost of maintaining the County Government for the year, 1920, in compliance with Section 1132 of the Compiled Statutes of Wyoming, 1910, was considered and after due calculations apportionment was made as follows:- to-wit:-

GENERAL FUND -----	\$ 56,000.00
ROAD & BRIDGE FUND -----	\$ 35,000.00 or as much thereof as may be necessary.
POOR & PAUPER FUND -----	\$ 10,000.00 or as much thereof as may be necessary.
DISTRICT COURT FUND -----	\$ 4,000.00 or as much thereof as may be necessary.
Total .....	\$105,000.00

SALE OF PROPERTY.

WHEREAS, James Blackhall has offered to pay to Carbon County to the amount of \$2.50, which amount will amply re-imburse Carbon County for all taxes, interest, costs and penalties incurred to date.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said James Blackhall for the sum of \$2.50 and the Chairman of the Board and the County Clerk are hereby authorized and directed to prepare and execute the proper deed of conveyance to the said James Blackhall.

BE IT RESOLVED, That whereas Lots 7 and 8 in Block 102 and Lot 6 in Block 22 in the Town of Grand Encampment, Carbon County, Wyoming were sold on July. 11. 1906 for 1905 taxes, and

WHEREAS, Said property was bid in at such sale by Carbon County, and

WHEREAS, The time for redemption has expired whereby title to said property passed into Carbon County, and

WHEREAS, M. K. Opperman has offered to pay to Carbon County to the amount of \$25.00 for said Property.

NOW THEREFORE BE IT RESOLVED, By the Board of County Commissioners that the said property be sold to the said M. K. Opperman for the sum of \$25.00 and the Chairman of the Board and the County Clerk and hereby authorized and directed to prepare and execute the proper deed of conveyance to the said M. K. Opperman.
