

PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, MARCH, 16. 1920.

Board met at 10 o'clock A. M. this 16th day of March A. D. 1920, In Special Session pursuant to call issued by Chairman Wm. A. Mc Kay, for the purpose of considering further action by the Board relative to the Hospital Bond Issue to be held in Carbon County, Wyoming, on the 23rd day of March A. D. 1920, advising the qualified Electors of Carbon County, Wyoming, of the objects of said Bond issue and such further information as the Board may deem advisable pertaining to said Hospital Bond Election.

Roll call showing present, Commissioner A. W. Rasmussen, Wm. A. Mc Kay, Chairman and R. A. Magor, Clerk. Commissioner R. T. Wood absent.

Proceedings were had as follows, to-wit:-

Upon motion duly made by Chairman Wm. A. Mc Kay and seconded by Commissioner Rasmussen and unanimously carried by the Board, the following Notice was ordered published in the Rawlins Republican Newspaper, the official newspaper of Carbon County, Wyoming, on the 18th day of March A. D. 1920, said paper a ^{news-}paper of general circulation throughout Carbon County, Wyoming, and in addition thereto that said notice be published during the week ending the 20th day of March A. D. 1920, in the Snake River Sentinel, of Baggs, Wyoming, in the Saratoga Sun of Saratoga, Wyoming, and in the Encampment Echo of Encampment, Wyoming, all being in Carbon County, Wyoming, and being all of the newspapers in said County.

NOTICE.

TO THE QUALIFIED ELECTORS OF CARBON COUNTY, WYOMING:

The 1919 Session of the Legislature of the State of Wyoming, has authorized any county of the State of Wyoming, to issue county bonds for the purpose of creating a fund with which to construct, acquire, and equip a county hospital, whenever the board of county commissioners shall have received proper and sufficient guaranties that not less than \$15,000 has been raised by donation and is available for the purpose. The board of County Commissioners of Carbon County, Wyoming, have heretofore received guaranties of \$15,000, raised by donation and is available for use in acquiring a suitable hospital for Carbon County, as by law provided.

The County commissioners believe it advisable and for the best interest of Carbon County and the inhabitants thereof to provide adequate hospital facilities for Carbon County and the inhabitants thereof, and to that end have heretofore, and on the 6th day of February, A.D., 1920, issued a proclamation and notice of a special election to be held in the several polling precincts in the various election district of Carbon County on Tuesday the 23rd, day of March, A.D., 1920, for the purpose of submitting to the qualified voters thereof the following question:

"Shall the Board of County Commissioners of Carbon County, State of Wyoming be Authorized and empowered to issue registered coupon bonds of the County to the Amount of one hundred thousand (\$100,000.00) dollars, in denominations of one thousand (\$1,000.00) dollars, five hundred (\$500.00) Dollars, and One Hundred (\$100.00) dollars, and bearing a certain rate of interest not exceeding six per cent per annum, payable semi-annually; said bonds to be payable at the option of said county ten years after date and absolutely due and payable twenty years after date, for the purpose of providing funds for the construction, acquisition and equipment of a County Hospital in and for said County as provided by Chapter 89 of the Session Laws of Wyoming, 1919?"

It now rests with the qualified voters of Carbon County whether or not said County will have adequate and properly equipped hospital within the boundaries thereof, and we urge that on next Tuesday the 23rd day of March, A.D., 1920, every voter who holds in his heart a wholesome interest for the welfare of Carbon County and the health and future happiness of its inhabitants go to the polling place in his election precinct and register his choice in this important matter.

THE POLLS WILL BE OPENED FOR VOTING DURING THE SAME HOURS OF THE DAY AND THE POLLING PLACES FOR THE VARIOUS ELECTION PRECINCTS ARE THE SAME AS FOR GENERAL COUNTY ELECTIONS.
