

## PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, APRIL, 6th. 1920.

Rawlins, Wyoming, April, 6th./1920.

A regular meeting of the Board of county commissioners of Carbon County, state of Wyoming, was held at the office of the county clerk (the usual meeting place), in the city of Rawlins, in said county and state, on April 6th. 1920, to-wit:- the 6th. day of April A. D. 1920, at the hour of 10 o'clock A. M. A quorum appearing to be present, the meeting was called to order by the chairman and the clerk was instructed to call the roll and, upon roll call, the following were found to be present:

The following proceedings, among others, were had and taken, to-wit:

The minutes of the previous meeting of the board were read and approved.

Thereupon, Commissioner Andrew W. Rasmussen introduced, read and moved the adoption of the following resolution and order:

WHEREAS, In accordance with that certain resolution of the board of County Commissioners of Carbon County, Wyoming, duly passed and entered of record on the 6th day of February, A. D. 1920, a special bond election was called and ordered to be held at the polling precincts in the various election districts in said County, on Tuesday, to-wit: the 23rd day of March, A. D. 1920, for the purpose of submitting to the qualified electors of Carbon County the proposition of issuing one-hundred thousand dollar (\$100,000) bonds of said county, for the purpose stated in resolution of February 6th, A. D. 1920; and

WHEREAS, It has been determined and it is hereby declared that the proclamation and notice of said special hospital bond election was posted and published as and in the manner, and for the time, required by law; that the ballots provided for and used at said election in voting upon said question were in the form required by law; that said election was held and conducted as nearly as practical in accordance with the general laws of said state; that each and every person voting at said election possessed the qualifications prescribed by law and in all respects at the time of voting was a duly qualified elector and resident of said county; that the ballots cast at said election upon the question submitted thereat were duly counted and return thereof made, accompanied by the ballots cast and the poll book and tally sheet used, to the board of county commissioners of said county, by the officers conducting said election at the polling places in each of the polling precincts, in the various election districts of said county, and that said returns were duly canvassed by the county clerk, who called to his assistance two justices of the peace of said county, and an abstract of the votes <sup>cast</sup> thereat was made and a certificate of the result was duly made by the county clerk, as and in the manner required by section 2243;

NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING, as follows:

1. That the bond election held at the polling places, in each of the polling precincts in the various election districts of Carbon County, state of Wyoming, on Tuesday, to-wit: the 23rd day of March, A. D. 1920, be and the same is hereby declared to have been duly called, noticed and held in strict compliance with law, as mentioned in the preamble hereof.

2. That the result of said bond election has been duly certified to and return thereof duly made to the board of county commissioners of said county by the board of canvassers, canvassing the returns of said election, as set forth in the preamble hereof.

3. That said canvass shows that, on the question submitted at said election, there were 1328 ballots in all cast at said election; that of said ballots there were 987 ballots cast "Hospital Bonds- Yes"; 330 ballots cast "Hospital Bonds- No"; 11 ballots were cast in error; and that a majority of 657 of the ballots <sup>cast</sup> at said election upon said question was in the affirmative and "Hospital Bonds - Yes".

4. That at said bond election a majority of the qualified electors, who were residents of said county, present and voting at said election, voted in favor of the issuance of one-hundred thousand dollar (\$100,000) bonds, for the purpose stated in resolution of February 6th. A. D. 1920, and it is, therefore, hereby determined and declared that said bond proposition has duly carried by the requisite majority vote and that this board is thereby duly authorized and empowered to issue and sell the negotiable coupon bonds of said county, of the character, to the amount, and for the purpose aforesaid.
