comes now, Joseph Cheesbrough, through and by his Attorney, A. J. Rosier, and files this his addition abjection to a proposed road passing through the Northwest Quarter of Section Ten, in Township Twenty-two, North Range Seventy-eight, as published by order of the Board of County Commissioners of Carbon County, Wyoming, based upon the following grounds:

That the said Board of County Commissioners of Carbon County, Wyoming, are without jurisdiction to establish said road, or to hear evidence concerning the establishment of said road, or to proceed further in the matter of said proposed ~~xxxxxx~~ road, for the reason that proper legal proceedings have not been conformed ^{to} by said Board to date, nor a proper legal petition to establish said road has not been filed or presented to said Board, as by law provided.
